**SUBJECT:** Housing Opportunities for Persons With AIDS (HOPWA) Contract of Services Awards

**BACKGROUND:** The U.S. Department of Housing and Urban Development (HUD) has sponsored a program titled Housing Opportunities for Persons with AIDS (HOPWA). This program provides localities with the resources and incentives to devise long-term comprehensive strategies for meeting the housing needs of persons with Acquired Immune Deficiency Syndrome (AIDS) or related diseases, and their families.

**BACKGROUND** (continued):

The City of Riverside received HOPWA funding for the Federal Fiscal Year 2006/2007 in the amount of \$996,423 to operate the HOPWA Program in the County of Riverside. On June 19, 2007, the Board of Commissioners authorized the Housing Authority to enter into an Agreement with the City of Riverside to administer the HOPWA Program as a program sponsor in Riverside County. In response to the Housing Authority's HOPWA Request for Proposals, Catholic Charities, Desert AIDS Project, and Inland AIDS Project submitted successful proposals to receive funds for short-term housing/utility assistance, project-based assistance, housing rehabilitation and supportive services – permanent housing placement. The proposed contracts will award Catholic Charities with \$130,557; Desert AIDS Project with \$256,079; and Inland AIDS Project with \$58,102. The total proposed amount of contracts to be awarded is \$444,738.

County Counsel has reviewed and approved the attached Contracts of Services. Staff recommends that the Board approve the attached documents.
