**BACKGROUND:**

On July 25, 2006 the Request for Proposal HSARC030 was done for Horse and other Equine Boarding Services for rescued animals. Department of Animal Services determined that the award should be split between the two vendors that can provide these services. Lavender Hill Farms would be the primary and Proud Horse Stable would be the secondary. The period of performance would be for five years beginning with the executed date of November 21, 2006, and renewing in one year increments.
