

BACKGROUND: By Minute Order 3.60 of July 17, 2007, the Board entered into an agreement with Elite Bobcat Service, Inc. of Corona, CA for the construction of roadway widening and sidewalk improvements, Bradley Road, Holland Road Southerly, Menifee area of Riverside County. The authorized amount of the contract was \$289,000.00. The total amended contract amount (including quantity adjustments) is \$284,017.90, which is 1.7% less than the originally authorized amount.



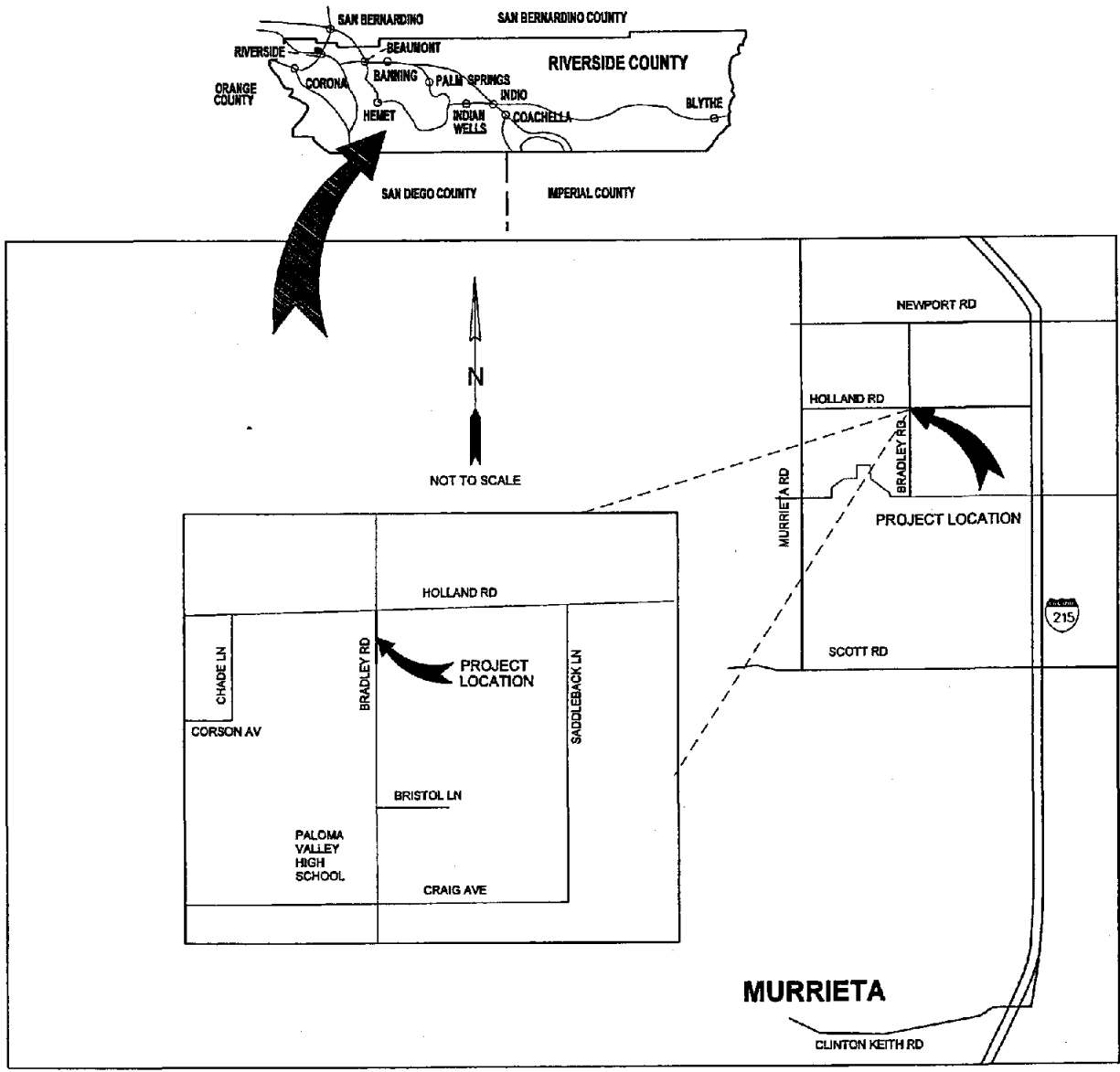
