
SUBJECT: Recommendation for Distribution of Excess Proceeds for Tax Sale No. 174, Item 97.
Last assessed to: Bertha M. Bragg, as Conservator of the Estate of Eva Cedenia Frierson.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Approve the claim from Eva Marie Welsh, Executor of the Estate of Ilos Joseph Frierson, surviving heir of Eva Cedenia Frierson for payment of excess proceeds resulting from the Tax Collector's public auction sale associated with parcel 373093009-2;
- 2) Authorize and direct the Auditor-Controller to issue a warrant to Eva Marie Welsh, Executor of the Estate of Ilos Joseph Frierson in the amount of \$22,411.74, no sooner than ninety days from the date of this order, unless pursuant to the California Revenue and Taxation Code Section 4675, an appeal has been filed in Superior Court.

BACKGROUND: In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the November 7, 2005 public auction sale. The deed conveying title to the purchasers at the auction was recorded January 9, 2006. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on January 30, 2006, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest.

The Treasurer-Tax Collector has received one claim for excess proceeds:

- 1) Claim from Eva Marie Welsh based on a Deed recorded March 3, 1930 as Book No. 840, Page No. 552, the Last Will and Testament of Eva Cedenia Frierson, Letters of Testamentary for Ilos Joseph Frierson, a Declaration under California Probate Code Sections 13100-13116 and the Death Certificates of Eva Cedenia Frierson and Ilos Joseph Frierson.

Pursuant to Section 4675 (a) & (f) of the California Revenue and Taxation Code, it is the recommendation of this office that Eva Marie Welsh be awarded excess proceeds in the amount of \$22,411.74. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion.
