**SUBJECT:** GENERAL PLAN AMENDMENT NO. 773/CHANGE OF ZONE  
No. 7255/CONDITIONAL USE PERMIT NO. 3486 – EA40565 – Applicant: Cocopah  
Nursery – Engineer/Representative: T.C. Morris - Fourth Supervisorial District – Mecca Zoning  
District – Eastern Coachella Valley Area Plan: Rural: Rural Residential (5 Acre Minimum) (RR) –  
Location: North of Avenue 66, south of Avenue 64, east of Highway 86, and west of Highway  
111 – 53.6 Gross Acres – Zoning: Light Agriculture – 5 Acre Minimum (A-1-5) - **REQUEST:** To  
amend the existing Eastern Coachella Valley Area Plan from Rural: Rural Residential (5 Acre  
Minimum) (RR) to Community Development: Medium High Density Residential (5-8 DU/AC)  
(MHDR); to change the existing zone from Agriculture: Light Agriculture – 5 Acre Minimum (A-1-  
5) to Mobile Home Subdivisions and Mobile Home Parks (R-T); and a conditional use permit  
which proposes to construct and operate a mobile home park containing 382 spaces with  
accessory recreational open space areas and structures.

**BACKGROUND:** The project applications were presented before the Planning Commission on  
April 19, 2006. After taking testimony and discussion from the applicant and the general public,  
the Planning Commission closed the public hearing and tentatively denied the project. On May  
31, 2006, the Planning Commission confirmed the denial action by adoption of a Planning  
Commission Resolution.
