SUBJECT: Approve the Sole Source Agreement between Desert AIDS Project and County of Riverside Community Health Agency, Department of Public Health for HIV Testing services.

RECOMMENDED MOTION: That the Board of Supervisors approve and;

- 1) Authorize the Chairman of the Board to ratify the Sole Source Agreement between Desert AIDS Project and County of Riverside Community Health Agency, Department of Public Health in the amount of \$70,000 for the period of July 1, 2007 to June 30, 2008; and
- 2) Authorize the Chairperson to sign four (4) originals of said Agreement on behalf of the County.

BACKGROUND: Desert AIDS Project (DAP) has provided HIV testing services since 1996 through ongoing contracts with the Department of Public Health. DAP has the facilities and experience is needed to provide the optimum provision of HIV testing services for the residents of Riverside County. The DAP has testing services at both their Palm Springs and Indio location, increasing access to testing to the residents of the Coachella Valley.

BACKGROUND CONTINUED:

HIV testing services provide the residents of Riverside County an opportunity to be tested to learn if they are infected, and if infected, receive referrals for HIV treatment and other needed services. The cost of this program is covered by a grant from the State Office of AIDS.

PRICE REASONABLENESS:

The re-imbusement rate for testing services is based on the current rate established by the State Office of AIDS. The rate that this vendor is charging is consistent with similar vendors for the same service in the western area of the County and all cost of this program is covered by a grant from the State Office of AIDS.

FINANCIAL DATA:

The cost of this agreement will be covered by a grant from the State Office of AIDS.
