**SUBJECT: HOUSING AND URBAN DEVELOPMENT GRANT
AGREEMENT—HOUSING AUTHORITY OF
RIVERSIDE COUNTY**

BACKGROUND:

On May 16, 2006 (Agenda Item 3.18), the Board authorized DPSS to submit an application for Homeless Assistance funds to the U.S. Department of Housing and Urban Development, which included the Shelter Plus Care (S+C) *East* Program operated by the Housing Authority. The goal of this renewal 11-unit, 20-bed project is to provide tenant based rental assistance for homeless mentally ill persons in the eastern part of Riverside County.

HUD approved the attached Shelter Plus Care project as part of the 2006 Continuum of Care Consolidated Application. HUD awarded the project to DPSS in the amount of \$133,584.

DPSS received the Grant Agreement on August 8, 2007. HUD executed the attached agreement on June 17, 2007 and we are now awaiting your Honorable Board's approval and signature.
