SUBJECT: Varner Road and Monterey Avenue Street Improvement Project

RECOMMENDED MOTION: That the Board of Supervisors approve the reimbursement agreement between the County of Riverside and the Coachella Valley Association of Governments in the amount of \$700,000 for the Varner Road / Monterey Avenue Street Improvement Project.

BACKGROUND: On July 31, 2007, the Board approved the plans and specifications, and authorized the Clerk of the Board to advertise the Notice Inviting Bids for the Varner Road and Monterey Avenue Street Improvement Project. Bids were opened on October 11, 2007 and Hazard Construction was the low responsive bidder. The project improves Varner Road and Monterey Avenue both aesthetically and functionally. These two streets are the main corridors into the Thousand Palms community and are in very poor condition. The scope of the project includes street widening, sidewalks, median, road reconstruction, striping, curbs, gutters and utility under grounding. Riverside County Transportation made an application to the Coachella Valley Association of Governments for a \$700,000 grant to supplement the budget for this project. (Continued on page 2)

Background continued: The Executive Committee of CVAG, at their October 25, 2004, meeting, approved a list of Regional Transportation Projects and the amounts recommended for funding through the RCTC bond sale process for the total amount of \$28,275,000. The total budget for the Varner Road / Monterey Avenue project is \$10,200,000. Staff recommends that the Board of Supervisors approve the CVAG reimbursement agreement for the \$700,000 and apply the funding to the Varner Road / Monterey Avenue project.
