4. Approve the funds to be sent to Caltrans in order for Caltrans to schedule the sign replacement with their crews.

**BACKGROUND:** This name change is in recognition of Harley Knox for his many contributions to the County of Riverside. In his vision for the area, he saw the need for an interchange at Oleander Avenue. Through Harley Knox efforts, the Oleander Interchange was constructed. The Board of Supervisors has directed the Transportation Department to process this name change per agenda item 3.25 approved on November 8, 2005. The city council of the City of Perris met on January 30, 2007 to authorize the street name change of Oleander Avenue to Harley Knox Boulevard. The Board of Supervisors will act to approve Fifth District CID funds to advance the funding for this project while a cooperative funding agreement is worked out between the County and the Cities of Perris and Moreno Valley. The Transportation Department has notified the adjacent property owners (9) of the proposed name change. The Historic Preservation Office was contacted and they have no objection to the street name change.
