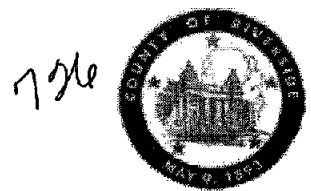

**SUBJECT:** Standard Agreement (TV-0708-21) Amendment 1 with the California Department of Aging (CDA) Senior Community Service Employment Program, 07/01/07 - 06/30/08

**RECOMMENDED MOTION:** That your Honorable Board:

1. Ratify and Authorize Chair to Execute Standard Agreement (TV-0708-21) Amendment 1 for FY 2007-2008 (July 1, 2007 to June 30, 2008) with California Department of Aging.
2. Direct the Auditor Controller to increase Estimated Revenues and Appropriations by \$68,882 as outlined Amendment 1.
3. Return four (4) Standard Agreements to the Office on Aging for further processing.

**BACKGROUND:** This agreement was originally approved on May 22, 2007 as agenda Item 3.31. It is being amended to include the mid year budget adjustments received from the California Department of Aging. The funds provided on this agreement support the operation of the Senior Community Service Employment Program, providing part-time employment/training positions for low income seniors 55 years of age and over in public and private not-for-profit agencies county wide.

The amended contract provides and additional \$68,882 as a result of and increase in the State fund allocation. This brings the total amount of the agreement with CDA to \$980,299. We are requesting no additional cash contributions and there is not impact on County General Funds.
