BACKGROUND: By Minute Order 3.44 of October 16, 2007, the Board entered into an agreement with All American Asphalt of Corona, CA for the resurfacing of various streets in the Monte Vista / Valle Vista Area of Riverside County

The authorized amount of the contract was \$296,881.06. The total amended contract amount (including quantity adjustments) is \$285,594.13, which is 3.8 % less than the originally authorized amount.
