11 County Ordinance 533.5 Section 7.2b, is hereby added to the County of Riverside list of
12 applicant agents, that is, those authorized to execute for and on behalf of the County of
13 Riverside, applications and documents as may be required by and filed with the State Office of
14 Emergency Services for the purpose of obtaining financial assistance under Public Law 93-288
15 as amended by the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1988, or
16 state financial assistance under the National Disaster Assistance Act. Mary Moreland is hereby
17 removed from the list because she no longer holds a position that qualifies her as applicant
18 agent. Larry Parrish, County Executive Officer, John Hawkins, County Fire Chief, and Robert
19 Byrd, County Auditor/Controller, shall remain on the list of authorized applicant agents.
