3. Direct the Clerk of the Board to send the required notice to the property owners as required per Section 1245.235 of the Code of Civil Procedure; and
4. Authorize the Auditor-Controller to amend Facilities Management's FY 2007/08 Real Property budget (7200400000) as specified on Schedule A.

**BACKGROUND:** The River Road Bridge is located on the Santa Ana River within the Prado Dam detention basin. Since construction of the dam, a process of sediment deposition has steadily raised the riverbed at the bridge crossing. This process has severely reduced the waterway opening under the bridge, subjecting it to debris accumulation, overtopping, and damage during even modest storm flows within the river. This situation has resulted in closures over extended periods of time, and it requires constant sediment removal to maintain the waterway. The bridge's width is substandard for its classification, and it is lacking standard shoulders, a sidewalk for pedestrian crossing and an adequate number of traffic lanes to accommodate expected future traffic. The bridge currently does not provide space for a planned regional recreation trail. The proposed project would provide a replacement bridge that would remedy these conditions (and other conditions).

In June, 2005, a Final Environmental Assessment (EA) and Environmental Impact Report (EIR) were jointly completed and approved by the Federal Highway Administration (FHWA), California Department of Transportation (Caltrans), and the Riverside County Transportation Department (RCTD) to evaluate a range of alternatives for replacing the existing River Road Bridge over the Santa Ana River in Riverside County and selecting a preferred project for subsequent design and construction.

The proposed project consists of the construction of a four-lane bridge of 1,200-feet in length, with approximately 1,000 feet of approach road on each side of the Santa Ana River. The proposed bridge will replace the existing two-lane, 612-foot long bridge, and would correct the noted deficiencies and provide for adequate traffic handling capacity.

The Department of Facilities Management (DOFM) has presented an offer to the property owners as required by Government Code, §7267.2. The price is consistent with current property values in the Norco area based on an independent appraisal report. DOFM has also offered to pay the reasonable costs, not to exceed \$5,000, for an independent appraisal as required by California Code of Civil Procedure, Section 1263.025.

Resolution No. 2008-082, Resolution of Necessity Regarding the Project to Improve River Road Bridge in Western Riverside County will be submitted to the Board on April 22, 2008, to permit the River Road Bridge Project to move forward.

The County is authorized to acquire property by eminent domain pursuant to Government Code §25350.5.

The Resolution has been reviewed and approved by County Counsel as to legal form.

7 **WHEREAS**, the portions of real properties that are the subjects of this Notice  
8 (collectively the "Subject Properties") are located in the State of California, County of Riverside;  
9 are legally described and pictorially depicted on the documents attached hereto as Exhibits "A"  
10 and "B" (and incorporated herein by this reference); are referred to on attached Exhibits "A" and  
11 Exhibits "B" as Parcels 0298-004A, 0298-004B, and 0298-005; are portions of larger real  
12 properties; and are generally located in the vicinity of the intersection of River Road and Bluff  
13 Street (in the cases of Parcels 0298-004A and 0298-004B) and in the vicinity of the intersection  
14 of River Road and Archibald Avenue (in the case of Parcel 0298-005);

15 **WHEREAS**, each one of the Subject Properties is listed below in Table One (across  
16 from the larger real property that includes the relevant Subject Property within its boundaries),  
17 and **WHEREAS** each one of those larger real properties is listed below in Table One by its

22 **WHEREAS**, the proposed project that is the subject of this Notice (the "Proposed  
23 Project") is one to replace the presently existing River Road Bridge (which crosses the Santa  
24 Ana River) with a new and improved River Road Bridge that will be wider, longer, and more  
25 highly elevated; and is one to improve a stretch of River Road bounded generally by Kendra

1 Lane on the north and Bluff Street on the south in order to integrate that stretch of road with the  
2 new and improved River Road Bridge, and in order to better protect that road from flooding  
3 (including, but not limited to, the use of the Subject Properties for public road purposes, for  
4 utility purposes, for drainage purposes, for slope purposes, for purposes of a staging area for  
5 construction and/or other work, and for other uses incidental to the Proposed Project and  
6 required by the Proposed Project);

7 **WHEREAS**, Parcel 0298-005 will be used for public road and utility and drainage  
8 purposes, and whereas the use(s) that will be made of each one of the remaining Subject  
9 Properties is/are described in attached Exhibit "A";

10 **WHEREAS**, the interests in property that are the subjects of this Notice (collectively the  
11 "Subject Property Interests") are perpetual easements in Parcels 0298-004A and 0298-005 and  
12 a temporary easement in Parcel 0298-004B (as listed below in Table Two):

17 **WHEREAS**, the statutes that authorize the County of Riverside to acquire the Subject  
18 Property Interests by eminent domain include Article 1, Section 19 of the California Constitution;  
19 Section 25350.5 of the Government Code; and Sections 1240.010, 1240.020, 1240.030,  
20 1240.040, 1240.110, 1240.410, 1240.510 and 1240.610 of the Code of Civil Procedure.

21 **NOW, THEREFORE, BE IT RESOLVED AND ORDERED** as follows by the Board of  
22 Supervisors of Riverside County, State of California, in regular session assembled on March  
23 18, 2008.

24 1. YOU ARE HEREBY NOTIFIED that this Board (at its public meeting on April 22,  
25 2008, at 9:30 a.m. in the meeting room of the Board of Supervisors located on the 1<sup>st</sup> floor of

1 County Administrative Center, 4080 Lemon Street, Riverside, California) may decide to adopt a  
2 Resolution of Necessity that would authorize the County of Riverside to acquire the Subject  
3 Property Interests by eminent domain (and that would find and determine each of the following  
4 matters):

5 (a) That the public interest and necessity require the Proposed Project;

6 (b) That the Proposed Project is planned or located in the manner that will be  
7 most compatible with the greatest public good and the least private injury;

8 (c) That the Subject Property Interests are necessary for the Proposed  
9 Project;

10 (d) That the offers required by Section 7267.2 of the Government Code have  
11 been made to the owners of record of the Subject Properties; and

12 (e) To the extent that the Subject Properties are already devoted to a public  
13 use, the use of the Proposed Project is a compatible use that will not unreasonably interfere  
14 with or impair the continuance of the public use as it presently exists or may reasonably be  
15 expected to exist in the future (California Code of Civil Procedure Section 1240.510) or the use  
16 of the Proposed Project is a more necessary public use than is the presently existing public use  
17 (California Code of Civil Procedure Section 1240.610).

18 2. If (within 15 days from the mailing of this Notice) you file a written request to  
19 appear at the public meeting and be heard on the matters described above in 1(a), 1(b), 1(c),  
20 1(d), and 1(e) (or any one or more of them), you will have a right to appear at that meeting and  
21 be heard on those matters.

22 3. All such written requests to appear and be heard must be filed with the Clerk of  
23 the Riverside County Board of Supervisors.

24 4. Your written request to appear and be heard must be filed within the 15-day time  
25 period. Failure to file such a timely written request will result in a waiver of your right to appear

1 and be heard.

2 5. Questions regarding the amount of compensation to be paid will not be a part of  
3 the public meeting and the Board will not consider such questions in determining whether a  
4 Resolution of Necessity should be adopted.

5 6. The Clerk of the Board of Supervisors shall cause a copy of this Notice to be  
6 sent by first-class mail to each person whose property may be acquired by eminent domain and  
7 whose name and address appears on the last equalized county assessment roll (including the  
8 roll of state-assessed property).

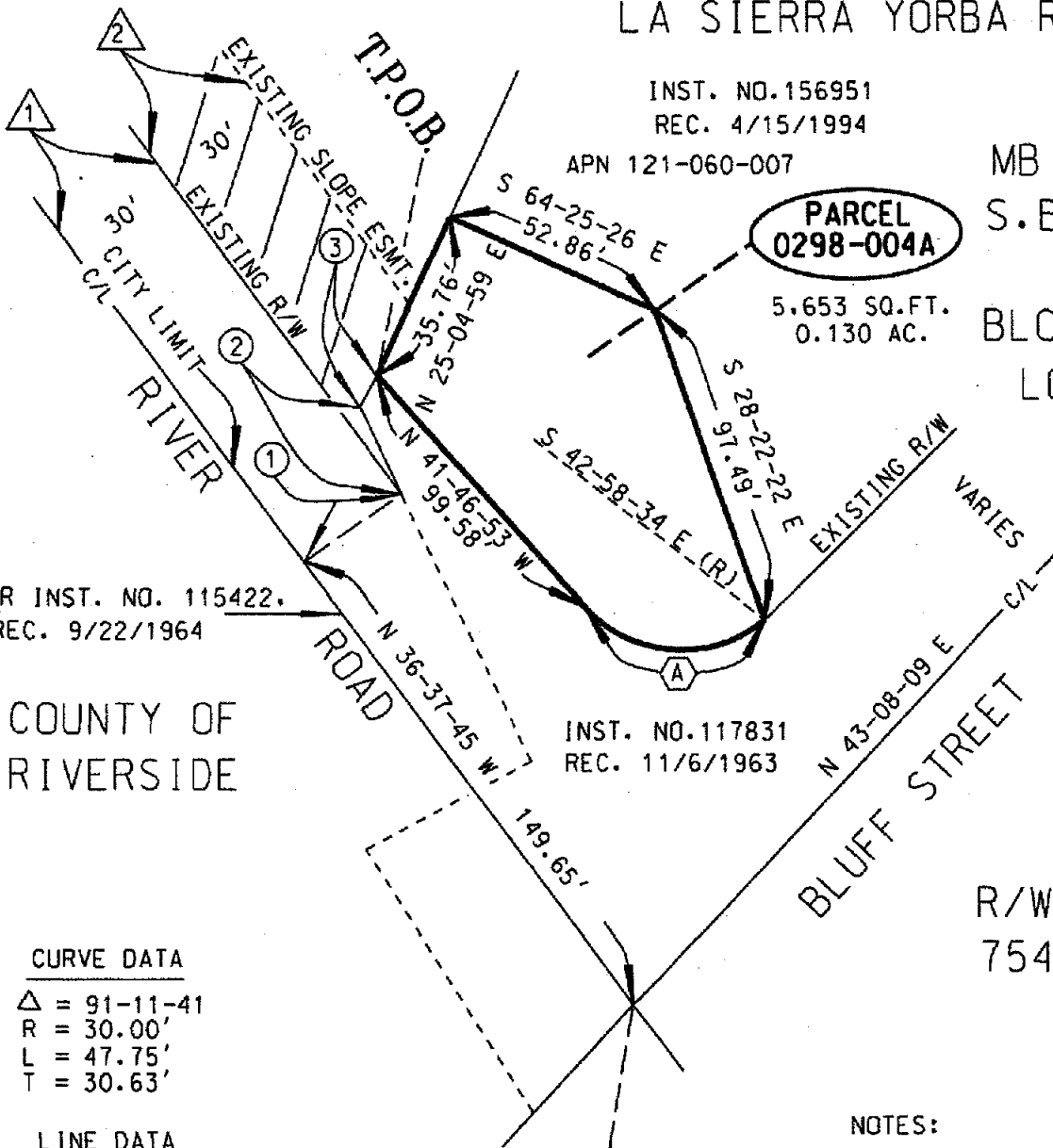
