**SUBJECT:** Approval of the Corvel Preferred Provider Organization Agreement with Riverside County Regional Medical Center (RCRMC) for hospital services

**RECOMMENDED MOTION:** That the Board of Supervisors:

- 1) Ratify the Preferred Provider Organization Agreement, effective February 1, 2008; and
- 2) Authorize the Chairperson to execute three (3) copies of the Agreement; and
- 3) Direct the Clerk of the Board to hold this Agreement as a confidential document, not subject to the release under the Public Records Act and Health and Safety Code Section, 1457 (C) (1); and
- 4) Direct the Clerk of the Board to return all three (3) copies of the signed originals to RCRMC Administration. Upon final execution by Corvel Healthcare Corporation, a fully executed agreement will be returned to the Clerk of the Board.

**BACKGROUND:** Corvel Corporation has recently added the County of Riverside as a client for workers compensation healthcare management services. As a result of this affiliation Corvel Corporation has requested that RCRMC join their network as a preferred provider for hospital services. This agreement is limited to workers compensation hospital services.
