BACKGROUND:

Since 1996, DPSS-CAP Riverside's Alternative Dispute Resolution Center has trained volunteers to provide mediation services to the Superior Court and the community. In 2006, DPSS-CAP Riverside developed a school-based peer mediation training module and currently provides training at three middle schools. School-based peer mediation trains students in conflict resolution and cultural diversity training to help reduce gang activity and violence on school campuses.

In the attached agreement with MVUSD, DPSS-CAP Riverside will provide fifteen (15) hours of Peer Mediation training at Bayside/Charter High School.

The Executive Director of DPSS-CAP Riverside requests that the Board approve the Agreement between MVUSD and DPSS-CAP Riverside covering the term April 7, 2008 through June 15, 2008.

FINANCIAL IMPACT: No County General Funds will be required.
