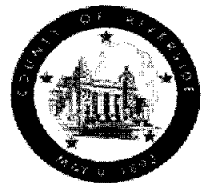



**PROCLAMATION
