**SUBJECT:** Change the Names of three roads: Change the Name of "A" Road to River Road, Change the Name of a portion of River Road to Baron Drive, and Change the Name of a portion of Archibald Avenue to River Road, in the Eastvale area, Second Supervisorial District

**RECOMMENDED MOTION:** Adopt Resolution No. 2008-042, changing the Names of three roads: "A" Road to River Road, a portion of River Road to Baron Drive, and a portion of Archibald Avenue to River Road.

**BACKGROUND:** This change is at the request of the Developer of Tract Map 30913-1, which is conditioned to facilitate the re-alignment and name changes per the General Plan. The re-alignment of River Road will follow the existing "A" Road, as shown on Tract Map 30913-1, to Archibald Avenue and continue along that portion of Archibald Avenue to the existing intersection of River Road and Archibald Avenue. In addition, that portion of River Road bypassed by the re-alignment will now become Baron Drive from the existing intersection of "A" Road and River Road to the existing intersection of River Road and Archibald Avenue. The adjacent property owners were notified of the proposed name change and the Transportation Department has not received any letters in opposition. Twenty-eight (28) letters were sent and four (4) responded in favor of the name change. Twenty-four (24) property owners did not respond.

The Historic Preservation Office was contacted and they have no objection to the street name change.

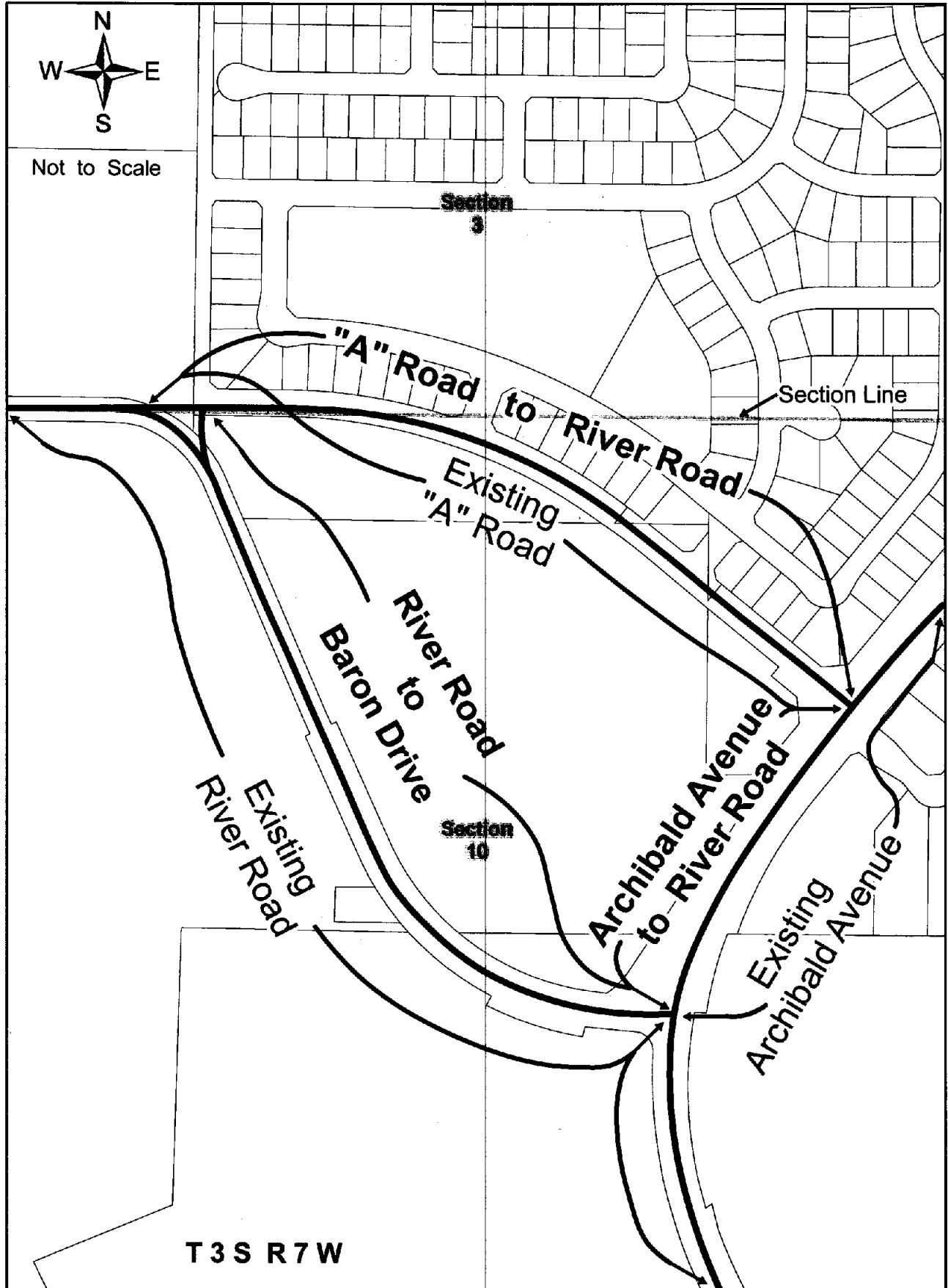

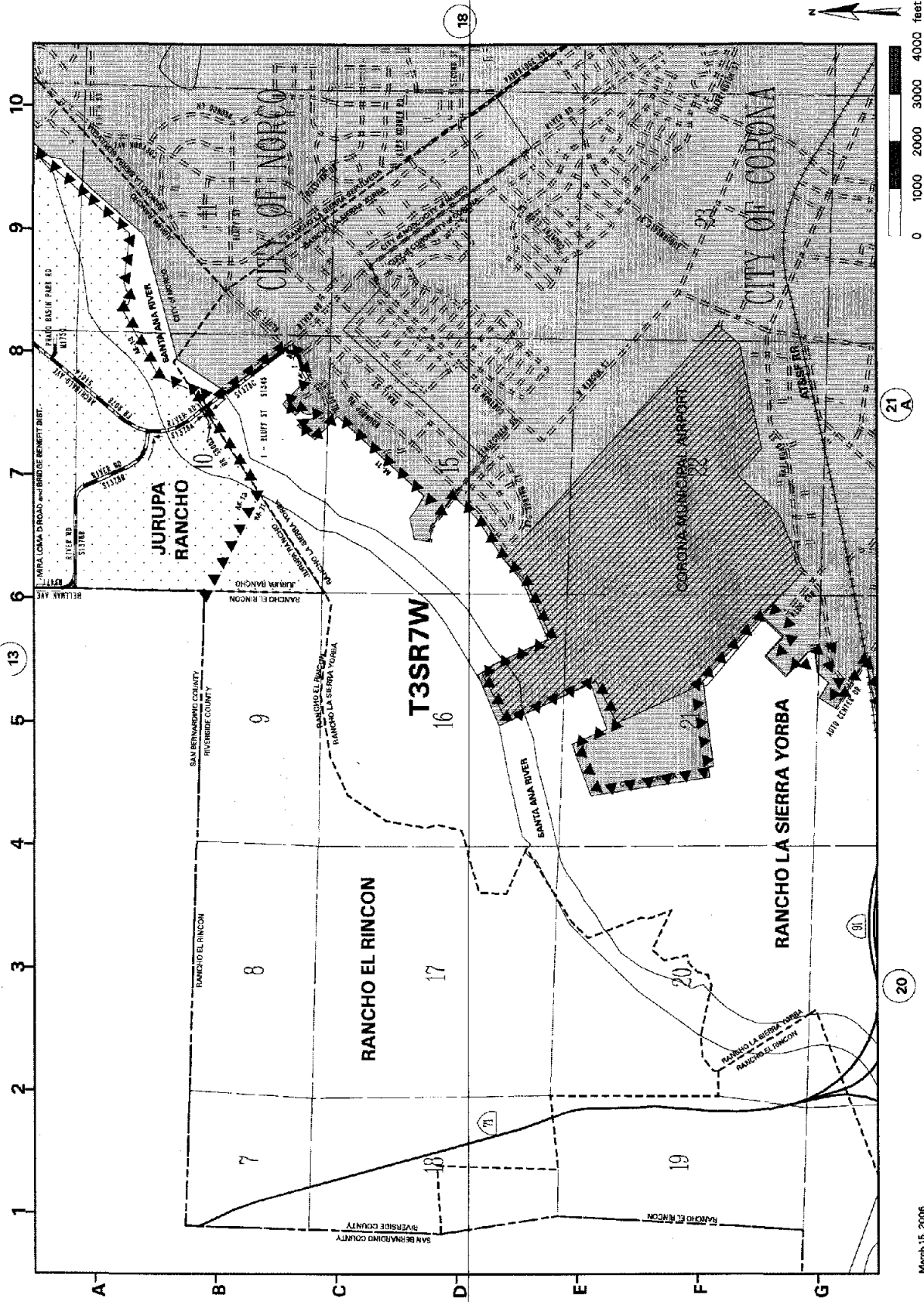
