BACKGROUND: California Elections Code §§ 10002, 10402, and 10403 allow jurisdictions to request that the Board of Supervisors approve the Registrar of Voters to conduct and consolidate elections by submitting a resolution requesting these services. The attached list of jurisdictions have complied with this requirement and request the Registrar of Voters to conduct and consolidate their elections. The department has the resources to conduct and consolidate these elections. The jurisdictions will reimburse the department based on associated direct costs.
