SUBJECT: Amendment #2 to Agreement SD2215-00 FY 2007/2008 with the Foundation for California State University, San Bernardino.

RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve and authorize the Chairman of the Board to sign and execute the attached second amendment to Agreement SD2215-00 with the Foundation for California State University, San Bernardino for the period of July 01, 2007 through June 30, 2008. The amendment increases the maximum reimbursable amount to \$285,250 to accommodate additional training.
2. Authorize the Purchasing Agent to sign any future Amendments to the Agreement, and to exercise renewal options on behalf of the Board not to exceed the maximum annual amount of the Agreement; and
3. Authorize the Director of DPSS to administer the terms of the Agreement.

SUBJECT: Amendment #2 to Agreement SD2215-00 FY 2007/2008 with the Foundation for California State University, San Bernardino.

BACKGROUND:

On June 12, 2007, (Agenda #3.31), your Honorable Board approved the agreement between the Department of Public Social Services (DPSS) and the Foundation for California State University, San Bernardino to provide core training to Children Services Social Services Workers.

The Foundation for California State University, San Bernardino has been under contract with the State of California since 1998 to provide initial and advanced training to the staff of the five Southern California Public Child Welfare Services agencies. California State University, San Bernardino is one of several educational institutions that are available to perform this service in Southern California.

DPSS negotiated the agreement with the Foundation without competition in accordance with California Department of Social Services (CDSS) manual section 23-650, paragraph 1.14, which states that contracts may be negotiated without formal advertising "for any service to be rendered by any federal, state or local governmental agency, public university, public college or other public educational institution." The rates for the training series were established and approved by the state and have been consistent since the Contract Agreement was executed in 2006.

On October 2, 2007, your Honorable Board approved and signed Amendment #1 (Agenda #3.45). Amendment #1 increased the number of courses being offered from five to eight.

The second amendment adds an additional course of training designed for Children Services Supervisors. The course is eight classes for thirty staff at a cost of \$17,250. The course follows the curricula developed by the California Social Work Education Center for the State of California to provide common training for Children Services' staff state wide.

Therefore, the Director of DPSS requests that the Board approve and sign Amendment #2 and authorize the Purchasing Agent to sign future ministerial Amendments not to exceed the contract maximum for fiscal year 2007/2008.

FINANCIAL IMPACT:

50.8% Federal, 34.1% State, 5.1% County, 10% Realignment Funds

The total cost to the County for these services is \$14,565.
