

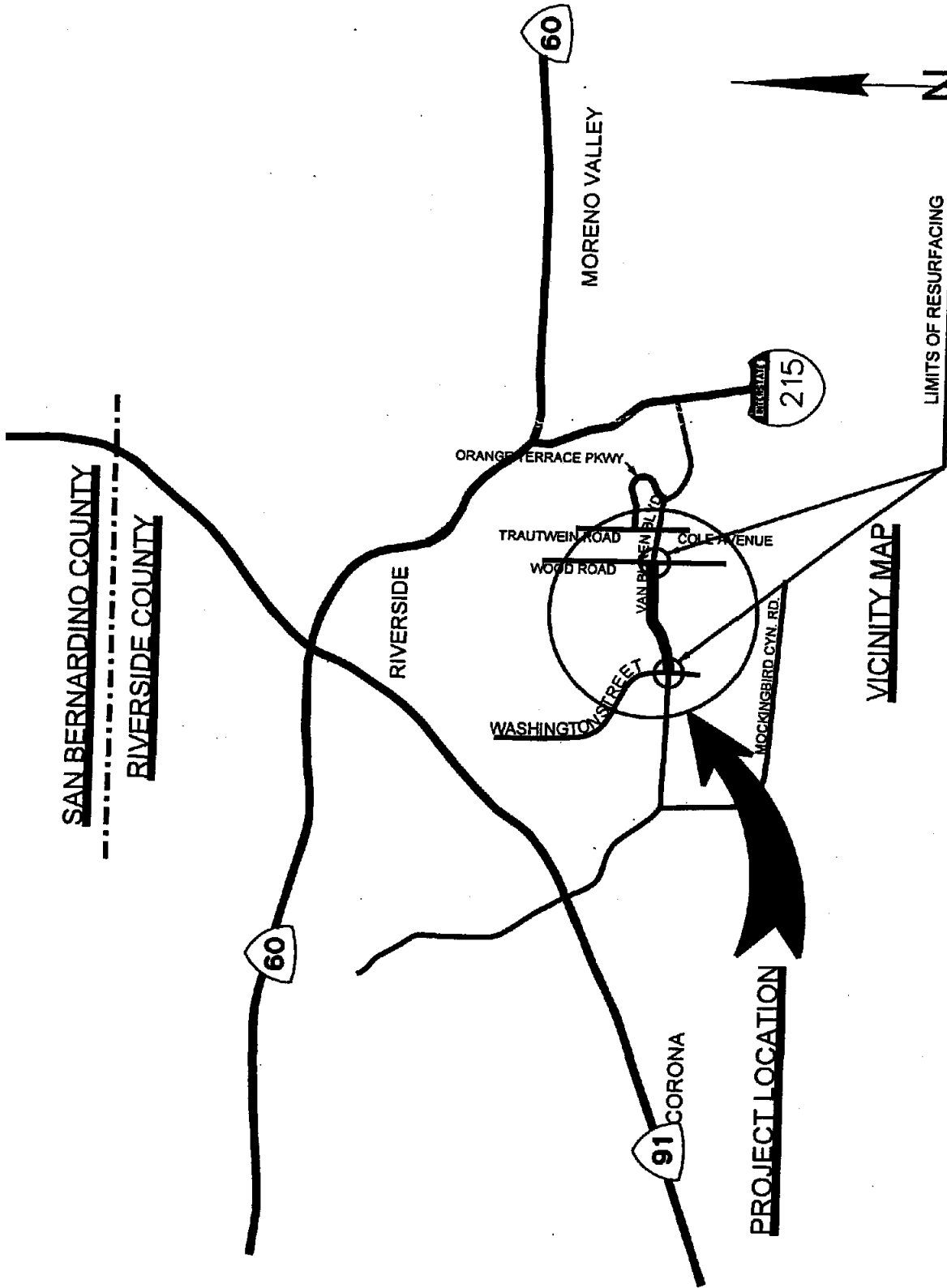

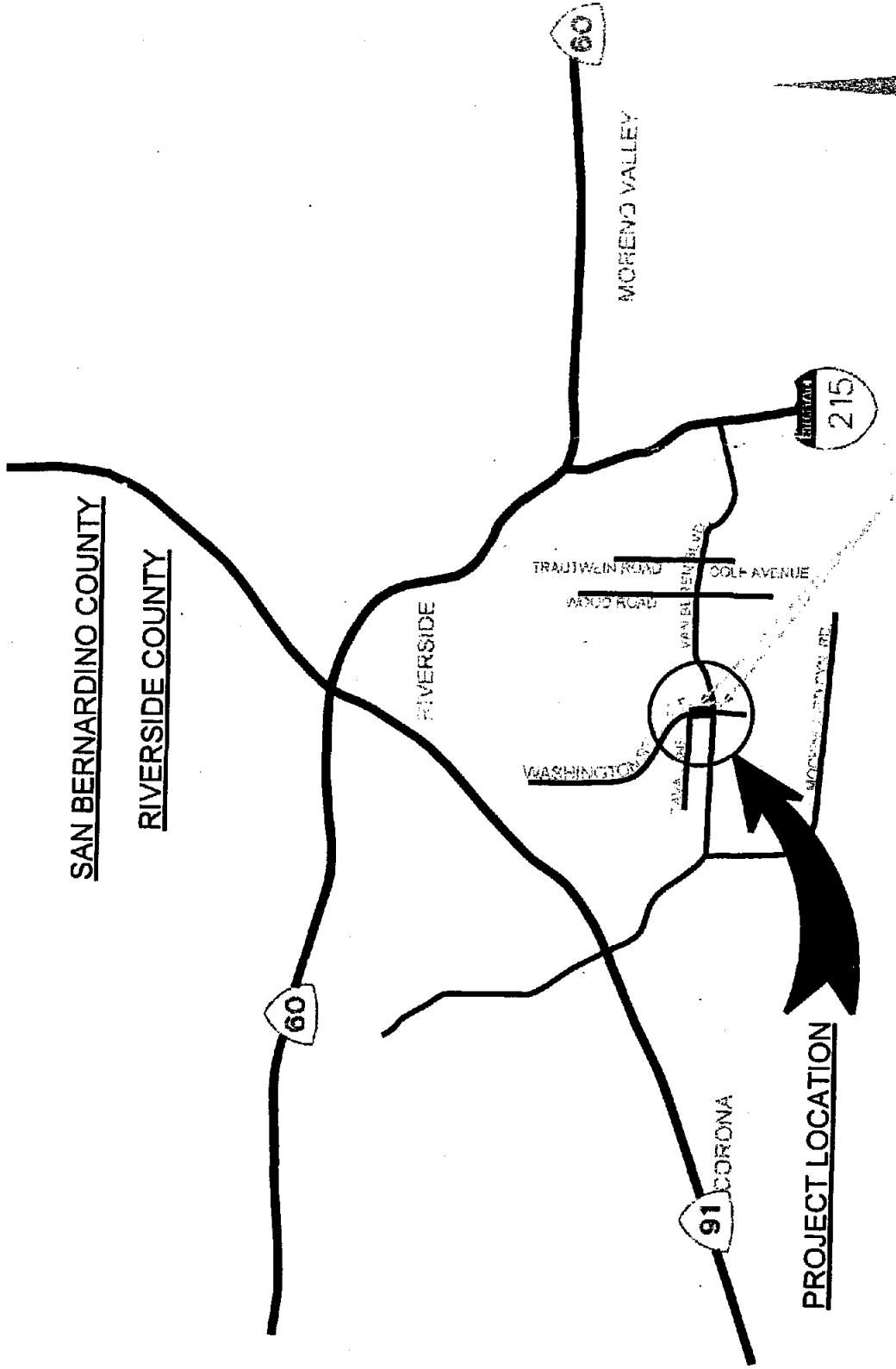
VAN BUREN BOULEVARD
