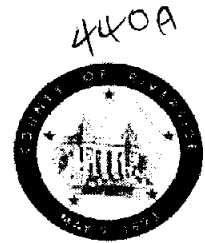

SUBJECT: Prevent Child Abuse Riverside County (PCARC) 2007 Annual Report

BACKGROUND:

On June 05, 2007 (Agenda Item #3.52), the Board re-designated PCARC as the lead Child Abuse Prevention Coordinating Council.

Welfare and Institutions Code (WIC) Section 18983 instructs Child Abuse Prevention Coordinating Councils receiving funding under this section whose primary purpose is to coordinate the community's efforts to prevent and respond to child abuse shall develop protocol for interagency coordination and provide yearly reports to the County Board of Supervisors.

Pursuant to the Agreement between PCARC and the Department of Public Social Services (DPSS), PCARC is required to submit an annual report of its operations and accomplishments to the Board. Therefore, the Director of DPSS requests that the Board receive and file the attached report for Fiscal Year 2007/2008.
