BACKGROUND: At its meeting of June 8, 2004, the Board voted to appoint Nick Nigosian as the County's representative on the Board of Trustees for the Coachella Valley Mosquito and Vector Control District ("CVMVCD"). Form 11 Reconfirmation of Nick Nigosian
May 1, 2008

The CVMVCD is a special district formed under Section 2200 et seq of the Health and Safety Code. Pursuant to Section 2021(d), the County may appoint one or more persons to create the Board of Trustees of five members. Pursuant to Section 2024, the terms of appointment are to be for two or four years at the discretion of the County. Terms of office are to commence on the first Monday in January, and follow the calendar year.

This reconfirmation and extension of the term of appointment would bring the appointment of Nick Nigosian into compliance with the first Monday in January rule mentioned above.
