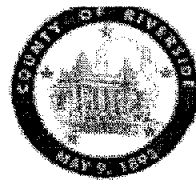



4 AN ORDINANCE OF THE COUNTY OF RIVERSIDE

5 AMENDING ORDINANCE NO. 858 PROHIBITING FIREWORKS
6

7 The Board of Supervisors of the County of Riverside ordains as follows:

8 Section 1. Subsection a. of Section 7 of Ordinance No. 858 is amended to read as

9 follows:

10 "a. Any person who violates any provision of this part is guilty of a
11 misdemeanor, and upon conviction shall be punished by a fine no less than
12 five hundred dollars (\$500.00) nor more than one thousand dollars
13 (\$1,000.00), or by imprisonment in the county jail for not exceeding one
14 year, or by both such fine and imprisonment. Notwithstanding the above, a
15 first offense may be charged and prosecuted as an infraction of not more than
16 one hundred dollars (\$100.00)."

17 Section 2. A new subsection e. is added to Section 7 of Ordinance No. 858 to read

18 follows:

19 "e. The penalties herein are in addition to any other remedies provided by law
20 and the payment of any penalty herein shall not relieve a person of the
21 obligation to correct the violation."
