**SUBJECT:** Edward-Dean Museum & Gardens – Legacy Rose Garden Project

**RECOMMENDED MOTION:** That the Board of Supervisors:

1. Approve the plans and specifications for the Edward-Dean Museum & Gardens – Legacy Rose Garden Project; and
2. Authorize the Clerk of the Board to advertise for bids for the construction of the Project.

**BACKGROUND:** In March 2007, phase one of the Edward-Dean Museum & Gardens campus improvements was completed to enhance the overall curb appeal and safety of the facility. The Legacy Rose Garden Project will serve as the second phase of the master plan for the campus. The improvements will include eight individual rose gardens set in symmetrical patterns to surround a gazebo with decomposed granite pathways. Placed within the garden will be statues representing the four seasons, benches and lighting. The intent of the garden is to attract more visitors and generate revenue from event rentals. Staff recommends approval of the above motions.
