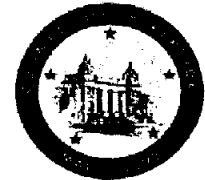

**SUBJECT:** Ratify the Amendment (07-132, A-2) between San Bernardino County, Department of Health and the Community Health Agency, Department of Public Health for HIV Medical Care and Pharmacy Services

**RECOMMENDED MOTION:** That the Board of Supervisors:

1) Ratify the Amendment (07-132, A-2) between San Bernardino County, Department of Health and the County of Riverside Community Health Agency, Department of Public Health for the performance period of April 1, 2007 through May 31, 2008 in the amount of \$25,870: for a new total of \$107,634.

2) Authorize the Chairperson to sign Four (4) originals of said Amendment, Contract 07-132, A-2 on behalf of the County.

**BACKGROUND:** The Ryan White Comprehensive AIDS Resource Act (RWCA) was enacted in 1990 to provide federal funding for comprehensive health and social services for persons living with the Human Immunodeficiency Virus (HIV) or Acquired Immunodeficiency Syndrome (AIDS).

**SUBJECT:** Ratify the Amendment (07-132, A-2) between San Bernardino County, Department of Health and the Community Health Agency, Department of Public Health for HIV Medical Care and Pharmacy Services.

**BACKGROUND: (Continued)**

As the payer of last resort, the RWCA is invaluable in filling the gaps in health care and social services for people living with HIV/AIDS. Funds from the RWCA are used to provide HIV care services, including medical and dental care, mental health care and treatment and HIV medications enabling people living with HIV/AIDS to live a longer and healthier life.

This amendment increases the County of Riverside Department of Public Health award by \$25,870 to provide HIV medications to qualified patients and extends the performance period to May 31, 2008

**JUSTIFICATION FOR DELAY:** Funds from the RWCA are distributed from the Health Resources Services Administration (HRSA) to San Bernardino County to Riverside County. Funding changes in the reauthorized RWCA caused delays in distribution of funds to San Bernardino County. The Department of Public Health received these agreements on March 23, 2008. This Form 11 and attachments were subsequently submitted to the County approval process.

**FINANCIAL DATA:** These grants do not require any county funds.
