HDR Engineering Inc. was selected as one of the top ranked firms to provide services on an "as needed" basis, estimated at \$500,000.00 annually. The Board of Supervisors approved and executed an agreement between the County and HDR Engineering Inc. on May 11, 2004 to provide the Transportation Department with the needed services. The agreement provided that the services be performed over a three year period with the option of providing up to two one-year extensions. On July 31, 2007 the Board of Supervisors ratified and executed an amendment that extended the period of services for one year. This amendment exercises the option in the agreement to extend the term of the contract for the second one-year extension.

All associated contract costs would be fully funded by Gas Tax, Measure "A," TUMF fees, RBBD fees, Developer fees and Permit fees. Thus, no Net County costs would be incurred as a result of this contract amendment.
