SUBJECT: Acceptance of the \$2000 Grant from the American Veterinary Medical Foundation

RECOMMENDED MOTION:

That the Board of Supervisors authorize the Director of Animal Services to accept the donation of \$2,000 from the American Veterinary Medical Foundation, and direct the Auditor Controller to make the Budget Adjustment shown on Attachment A.

BACKGROUND:

In October 2007, the Department of Animal Services (DAS) played an instrumental part in helping evacuate and house animals affected by the wild fires that affected much of San Diego and Orange Counties and the simultaneous wind storms that affected these same areas as well as a large portion of Riverside County. DAS expended a large amount of resources through these services and applied for a grant with American Veterinary Medical Foundation (Foundation) to help cover these costs.

This grant is to help provide care and housing of animals during disasters. The Foundation recognizes such efforts by veterinarians and others, engaged in both private and public practice, when health, safety and welfare are at risk. DAS received the maximum award of \$2,000.
