SUBJECT: State of California Employment Training Panel (ETP) Funding Agreement #ET08-0432 for Program Years 2008/10

RECOMMENDED MOTION: That the Riverside County Board of Supervisors accept the State of California Employment Training Panel funds in the amount of \$495,450 to provide Licensed Vocational Nurse training to for-profit health care businesses in the Coachella Valley, and authorize the Director of Workforce Development or her designee to develop and execute contracts under this Agreement.

BACKGROUND: Effective January 1, 2006, Senate Bill 102 allowed the State of California Employment Training Panel (ETP) to fund up to 5 Licensed Vocational Nursing (LVN) programs in the State of California. On April 28, 2006, ETP selected the Riverside County Economic Development Agency's (EDA) proposal to provide the LVN program in Riverside County and approved \$469,260 to train 45 participants. The California Nurses Educational Institute (CCNEI) in Cathedral City was the contracted training provider and will meet all expected benchmarks by June 30, 2008.

On April 10, 2008, ETP again selected EDA's application to provide the LVN program and approved \$495,450 to train an additional 45 participants. Because of its previous success, CNEI will be the training provider through June 30, 2010. All contracts executed under this agreement will be approved by County Counsel prior to execution.
