**SUBJECT:** Workforce Investment Act (WIA) Title 1B Community College Education Assistance Center (CCEAC) Funding Recommendation

**RECOMMENDED MOTION:** That the Riverside County Board of Supervisors:

1. Approve the recommendation funding of \$185,000 to Riverside Community College District (RCCD) to operate the CCEAC for Program Year (PY) 2008-2009; and
2. Authorize the Director of Workforce Development to negotiate and execute an agreement.

**BACKGROUND:** The Riverside County Workforce Development Board identified the need for enhanced workforce linkages to education, especially to the community college system; this prompted the procurement for a CCEAC. The CCEAC will provide access to WIA services to job seekers on the community college campus for Workforce Development Center customers. The project will seek to attract customers who may otherwise be reluctant to enter a two-year college because of the lack of comfort and familiarity with the wide array of educational resources offered by the community college system. The goal is to illustrate the relationship between post-secondary learning and enhanced career paths.

On February 13, 2007, a Request for Proposal (RFP) was released soliciting applicants able to develop and deliver the CCEAC services described in the RFP. The procurement covered a period of three years, effective July 1, 2007 through June 30, 2010. RCCD submitted the only proposal.

Recommendation for funding is based on RCCD's ability to service the residents of Riverside County in achieving their academic and career goals. At the April 16, 2008 meeting the Workforce Development Board's Executive Committee approved the recommended funding for program year 08-09.
