SUBJECT: Mission Boulevard Revitalization Plan, Phase V

RECOMMENDED MOTION: That the Board of Directors approve and authorize the Chairman to execute the attached Second Amendment to the Agreement between the Redevelopment Agency for the County of Riverside (Agency) and Krieger and Stewart, Inc. (Consultant).

BACKGROUND:

Previously, the Board approved the Consulting Services Agreement to provide plans and specifications for the Mission Boulevard Revitalization Plan, Phase V, from one hundred feet (100') west of La Rue Street to Valley Way, in the unincorporated community of Rubidoux. Subsequently, the Agency approved the First Amendment to the Agreement, which extended the time of performance to complete the services required under the original Agreement. The Second Amendment to the Agreement will increase the Consultant's scope of services to provide traffic signal modification plans, storm drain design, median reconstruction at Valley Way, and legal descriptions and plats for right-of-way dedication.

Agency staff recommends the Board approve and authorize the Chairman to execute the attached Second Amendment to the Agreement.
