

Salaries for our Environmental Health and Hazardous Materials Management Specialist staff increased by a 6% COLA in October of 2007 and will increase 2% in October 2008. Due to an oversight, the 6 % COLA was not incorporated in last year's fee increase. This and the additional 11% (Hard to Recruit) added to the top step for Environmental Health Specialists who work in our desert offices adds to the increase needed this year. Our other SEIU staff will receive a 3% COLA. The LIUNA staff will receive a 2.5% COLA with a 2.71% step increase in May of 2008 (exception - Environmental Health Technicians 5.5% COLA). The fee increases in this proposal and projected increases in service will generate sufficient revenue to cover projected costs through FY 08/09.

Summary of Fee Changes

A strike-out version (Attachment 1) and a final version (Attachment 2) of the ordinance changes, as well as a Fee Comparison Chart (Attachment 3) are attached for your review. The fee categories contained in these documents are in the same order as the activities described below. Except for hourly rates, all fees have been increased 10%. For the past four years, fees have been raised an average of 6.75% per year.

A summary of changes to the text of the Ordinance are as follows:

Mobile Food Facilities

The new California Retail Food Code added a provision for "Mobile Support Units" so this new category has been added for permitting and plan checking these units. Additional plan check categories have been added for mobile food facilities that serve pre-packaged potentially hazardous food or require a remodel due to changes in food service.

Processing Solid Waste Facility Permits

Language was added to clarify the types of solid waste facility permits included under this category.

Aircraft Holding Tanks

We are already inspecting the effluent waste tanks from aircraft which are transported for disposal; these portable tanks are commonly referred to as "Lavatory Karts." This category has been added for clarification and to provide for a lesser, more appropriate, fee for this service.

Property Liens for Unpaid Trash Collection Services

This new fee category will allow us to recoup our costs for placing property liens on parcels where the owners have failed to pay the mandatory trash collection charges in the County's Trash Collection Franchise Areas.

Water Well Sampling

This new fee category will enable us to recoup costs for the analysis of water samples for certain chemical constituents based on local conditions. This would be in addition to the standard bacteriological and the three chemical compounds that are already being analyzed as part of a private water well evaluation to aid in determining potability. This additional chemical sampling will be conducted where elevated levels of compounds that have public health significance are found. A copy of the results would be provided to the homeowner.

FINANCIAL DATA

These proposed fees have been reviewed and approved by the County Auditor/Controller. If approved, the fee adjustments will result in an increase in revenue to the Department of approximately \$1,935,020 annually. These fee increases have been included in the FY 08/09 Budget.

The Department derives approximately 71% of its revenue from the fees in this Ordinance. The majority of the other revenue comes from Ordinance No. 671 "Land Use Related Fees," Franchise fees, and Landfill Tipping fees. Due to the down turn in the building industry, Ordinance No. 671 and Landfill Tipping fees are projected to decrease by approximately \$2,349,800 even with increases in proposed rates. This projected deficit has been addressed by defunding 14 positions in the proposed FY 08/09 Budget as well as requesting an add-back policy item in the amount of \$593,742 to fund six positions in the Land Use Program.

ORDINANCE NO. 640. 11

AN ORDINANCE OF THE COUNTY OF RIVERSIDE,
AMENDING ORDINANCE NO. 640 ESTABLISHING ENVIRONMENTAL HEALTH
SERVICES FEES

The Board of Supervisors of the County of Riverside ordains as follows:

Section 1. Section 13. of Ordinance No. 640 is amended to read as follows:

“Section 13. Required Fees.

No person, corporation, association, firm, business or entity shall operate, perform, carry on, conduct or engage in any of the activities delineated in this Section without paying the fee listed in this section for the activity and obtaining a receipt therefore from the Department of Environmental Health.
