SUBJECT: Hurkey Creek Park – Maintenance Building and Area Improvement Project Contract Documents and Bids - District III

RECOMMENDED MOTION: that the Board:

1. Accepts and approves the contract documents for the improvements to the Hurkey Creek Park Maintenance Building and surrounding area; and
2. Authorizes the Clerk to the Board to advertise for bids and schedule a bid opening date of July 3, 2008, at 10:00 a.m.

BACKGROUND: The Park District has completed the contract documents (plans and specifications) for the rehabilitation of the Hurkey Creek Park maintenance site, located along Highway 74 in the San Jacinto Mountains in western Riverside County. The work generally consists of the rehabilitation of the existing maintenance structure (new upgraded electrical service, new windows and doors, and installation of interior walls), the construction of a new storage building, and upgrades to the existing septic system. The estimated cost for this work is \$187,200. The Office of County Counsel has reviewed and approved the agreement as to legal form.
