RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Approve the Riverside County Child Care Consortium Agreement for Partner Agency Services between the Riverside County Child Care Consortium and the Community Health Agency, Department of Public Health from July 1, 2008 through June 30, 2009, in the amount of \$ 93,000 with options to extend the term for one (1) additional term of three (3) years; and
- 2) Authorize the Purchasing Agent to sign subsequent amendments not to exceed authorized amount, including extension amendments until June 30, 2012.
- 3) Authorize the Chairperson to sign four (4) originals of said Agreement on behalf of the County.

SUBJECT: Approvethe Riverside County Child Care Consortium Agreement for Partner Agency Services between the Riverside County Child Care Consortium and the Community Health Agency, Department of Public Health.

BACKGROUND: Riverside County Community Health Agency, Department of Public Health, Nutrition Services Branch is a continuing contractor with the Riverside County Child Care Consortium.

The Riverside County Child Care Consortium has awarded Riverside County Community Health Agency Department of Public Health funding in the amount of \$ 93,000 for the "Healthy You and Me" Obesity Prevention Program. The program will provide eight workshops to childcare providers as well as individual site visits to assist child care providers with promotion of healthy eating and physical activity.

The Obesity Prevention Program will promote and support good nutrition and physical activity as the norm for families. Obesity prevention strategies will focus on individual, social, economic and environmental behavior changes. The goal will be to encourage families to make healthy lifestyle changes. Families will learn how to implement nutritional behavior changes at home and in their community, enhancing the physical and emotional well being of their children.

FINANCIAL INFORMATION: The Riverside County Child Care Consortium has awarded Riverside County Community Health Agency Department of Public Health funding in the amount of \$ 93,000 for the "Healthy You and Me" Obesity Prevention Program. The program year is based on the FY, July 1, 2008 – June 30, 2009.
