**SUBJECT:** Approval of services Contracts/Amendments exceeding \$100,000 to provide HIV/AIDS Prevention Education Services to the County for the Department of Public Health HIV/AIDS Program

**RECOMMENDED MOTION:** That the Board of Supervisors:

- 1) Approve and authorize the Chairman to sign services Contracts/Amendments exceeding \$100,000 annually to provide HIV/AIDS Prevention Education Services, and;
- 2) Authorize the Purchasing Agent to sign subsequent amendments with completion date of June 30, 2010.

**BACKGROUND:** The Department of Public Health, HIV/AIDS Program has been actively involved in reducing and eliminating the spread of HIV disease within Riverside County through its many prevention programs. To assist in these efforts, the HIV/AIDS Program utilizes community based non-profit agencies who are specialists in these services to assist in executing the education efforts for hard to reach and underserved populations.

**SUBJECT:** Approval of services Contracts/Amendments exceeding \$100,000 to provide HIV/AIDS Prevention Education Services to the County for the Department of Public Health HIV/AIDS Program

**BACKGROUND: (continued)**

As a result of a Request for Proposal (RFP) conducted by the County Purchasing Agent in the Spring of 2007, the Community Health Agency awarded four vendors who provide HIV prevention services to different targeted communities within Riverside County.

On October 23, 2007, Item 3.7 the County of Riverside approved the agreements with the four (4) vendors exceeding \$100,000, collectively, with options to renew for two (2) additional years.

The Community Health Agency is requesting the Board of Supervisors to renew the four agreements for Fiscal Year (FY) 08/09 in the following amounts;

Bienestar Human Services	\$49,393
Desert AIDS Program	\$231,397
First Chance/Y-Chow	\$22,454
Inland AIDS Project	\$141,459

All services will continue to be performed as directed by the Department of Public Health, HIV/AIDS Program in accordance with all current policies.
