**SUBJECT:** Approval of Contracts for Child Abuse Prevention, Intervention and Treatment (CAPIT) and Promoting Safe and Stable Families (PSSF) Programs

**RECOMMENDED MOTION:** That the Board of Supervisors approves and:

- 1) Instructs the Chairman of the Board to sign the attached Agreements to provide child abuse prevention and treatment services for Fiscal Year 2008-2009, with options to renew through Fiscal Year 2010-2011, with a total annual aggregate amount not to exceed \$955,853, funded by Child Abuse Prevention Intervention and Treatment (CAPIT) and Promoting Safe and Stable Families (PSSF);
- 2) Authorizes the Purchasing Agent to sign any ministerial, additional services amendments, and renewals consistent with the original agreements, not to exceed \$955,853; and
- 3) Authorizes the Director of the Department of Public Social Services (DPSS) to administer the Agreements, sign assurances, exhibits, and reports under the Agreements.

**SUBJECT:** Approval of Contracts for Child Abuse Prevention, Intervention and Treatment Services (CAPIT) and Promoting Safe and Stable Families (PSSF) Programs

**BACKGROUND:**

On October 2, 2007 (Agenda #3.48), the Riverside County Board of Supervisors received and filed the 2007 Prevent Child Abuse Riverside County (PCARC) Needs Assessment for Riverside County. Based on the Needs Assessment, the RFPs were formulated for release in a collaboration process between Prevent Child Abuse Riverside County (PCARC), DPSS and County Purchasing. Six RFP's were approved by the Board on November 27, 2007 (Agenda #3.17) to obtain child abuse prevention and treatment service for Fiscal Years 2008-2009 through 2010-2011 and released by County Purchasing and Fleet Services on December 3, 2007.

On April 22, 2008 (Agenda #3.24), the Board approved the final award recommendations for the CAPIT and PSSF core services, Family Preservation Court/Time Limited Reunification (FPC/TLR), and Differential Response (DR) Program Evaluator proposals. As noted in that Form 11, DPSS is bringing the Agreements over \$100,000 to the Board for signature.
