**BACKGROUND:**

CDC is providing funding to counties as part of a statewide outreach campaign, Seniors Against Investment Fraud (S.A.I.F), designed to inform seniors on how to avoid investment scams and fraud schemes.

If approved, DPSS will utilize these funds to:

- Train volunteers who will educate seniors of Riverside County about these fraud scams; and
- Promote the S.A.I.F. program in partnership with appropriate local law enforcement and consumer groups.

DPSS currently utilizes three volunteers to assist with S.A.I.F. presentations that have been attended by over 8,800 people throughout Riverside County since July 1, 2007.

The Board last approved a S.A.I.F. revenue agreement with the California Department of Corporations on 07/31/07 (#3.80).

**FINANCIAL IMPACT:**

The entire program is funded by CDC. No County funds are requested.
