**SUBJECT:** Approval to purchase fixed assets.

**RECOMMENDED MOTION:** That the Board of Supervisors:

1. Approve the purchase of a medical grade monitor.
2. Authorize the Purchasing Agent to purchase the monitor not to exceed \$7,000.
3. Direct the Auditor-Controller to adjust the FY 07/08 budget per Schedule A.

**BACKGROUND:** The medical grade monochrome monitor will be used for diagnostic viewing of the digital x-rays in the Riverside Neighborhood Clinic. This monitor is tailored specifically to adjust the grayscale tone characteristics of monitors used in the medical field, offering highly refined images.

**FINANCIAL DATA:** Clinic Management has \$7,000 available to purchase this equipment from transfer of funds from Appropriation (2) to Appropriation (4).
