**SUBJECT:** Apron Rehabilitation Construction Management Services Contract

**RECOMMENDED MOTION:** That the Board of Supervisors approve and authorize the Chairman to execute the attached contract between the County of Riverside and Mead & Hunt, Inc. for the Apron Rehabilitation project at Jacqueline Cochran Regional Airport.

**BACKGROUND:** The purpose of the project is to conduct repair and rehabilitation of an aircraft parking apron and necessary improvements at the Jacqueline Cochran Regional Airport, consistent with the airport's Capital Improvement Program. This contract is between the County of Riverside and Mead & Hunt, Inc. for construction management services for the Apron Rehabilitation project. Due to the firm's level of familiarity with the project, staff proposes to have Mead & Hunt, Inc. provide construction management, inspection and engineering services necessary to complete the project. The Federal Aviation Authority (FAA) has concurred with this request.
