**SUBJECT: AMENDMENT #1 TO THE AGREEMENTS  
WITH ALTERNATIVES TO DOMESTIC VIOLENCE  
AND SHELTER FROM THE STORM**

**RECOMMENDED MOTION:** That the Board of Supervisors ratify and:

1. Authorize the Chairman of the Board to sign the attached Amendment No.1 to the Agreements between Riverside County Department of Public Social Services (DPSS), Alternatives to Domestic Violence and Shelter from the Storm, to provide Domestic Abuse Advocacy Intervention Services. The total amount of the Amendments are not to exceed \$304,032 and \$164,790 respectively for the period of July 1, 2007 through September 30, 2008.
2. Authorize the Purchasing Agent to approve and execute any future ministerial amendments to these Agreements and exercise renewal options for an amount not to exceed the maximum agreement amounts.
3. Authorize the Director of DPSS to administer the terms of these Agreements.

**BACKGROUND:**

On August 23, 2005, Agenda No 3.69, and on February 7, 2006, Agenda No. 3.29, the Board of Supervisors approved the agreements with Alternatives to Domestic Violence (ADV) and Shelter from the Storm (SFTS) with a maximum reimbursable amount of \$243,226 and \$131,832 respectively. We are requesting an extension of the current agreements to September 30, 2008 to continue services while the Request for Proposal process is completed and new contracts are awarded.

ADV provides domestic abuse advocacy services to CalWORKs applicants and recipients of the Central and Western portions of Riverside County. Service under this contract includes case management, individual counseling, referrals to medical and social services, relocation assistance and emergency shelter, parenting programs, temporary restraining order assistance, court accompaniment and life skills training which include financial planning, anger management, and coping with stress.

SFTS provides emergency shelter and comprehensive community-based services for victims of domestic violence in eastern Riverside County. SFTS assists DPSS in the identification and support of CalWORKs clients who are victims of abuse. Service under this contract includes domestic violence advocacy to screen, identify and provide appropriate referrals to CalWORKs applicants and recipients who are victims of domestic violence.

**FINANCIAL IMPACT:**

The Contracts will be funded with Federal, Realignment, and County Funds. Total contract cost and revenue were included in the FY08/09 budget.
