SUBJECT: FY 2008 – 2009 - Medical Services Agreement with Clinics for the Medically Indigent Services Program (MISP).

RECOMMENDED MOTION: Move that the Board of Supervisors:

- 1) Authorize the Medically Indigent Services Program (MISP) to pay for medical services and pharmaceuticals without securing competitive bids in accordance with Ordinance 4594.4.
- 2) Exempt the Purchasing Agent from the requirement to report sole source agreements when adding medical services providers and pharmaceutical vendors to the existing list of providers.
- 3) Authorize the Medically Indigent Services Program (MISP) to pay for medical and pharmaceutical services not to exceed the annual aggregate amount of \$10,427.635.
- 4) Authorize the Purchasing agent to renew these agreements annually for up to three one year periods in amounts not to exceed the program budget limits.

BACKGROUND: The Medically Indigent Services Program (MISP) functions as a fiscal intermediary for the reimbursement of medical services and pharmaceuticals provided to the medically indigent, county adult and juvenile prisoners, and managed care patients assigned to the County's providers. In this role, MISP makes payments to a large number of physician groups, hospitals, and pharmacies. Most of the reimbursement that MISP provides is for emergent care, and because of this, the department is not able to identify all the providers in advance of the services provided.

PRICE REASONABLENESS: MISP reimburses its providers using Medi-Cal rates which are established by the State of California. Because there is no negotiation regarding the reimbursement rates, the Department is requesting to pay for these services without seeking competitive bids.

There are sufficient funds in the Department's proposed budget. The indigent care is funded through realignment sales tax and vehicle license fees (California Welfare and Institutions Code 17600). The current estimated funding for fiscal year 2008-09 is approximately \$5,353,700. The department is fully reimbursed for any reimbursements that it makes on behalf of the county adult and juvenile prisoners by Detention Health Services. Detention Health is budgeted at \$2,412,949. MISP is also reimbursed by Riverside County Regional Medical Center for indigent patients who need a higher level of care which is estimated at \$2,660,986.
