BACKGROUND: By Minute Order 3.24 of April 8, 2008, the Board entered into an agreement with Hillcrest Contracting, Inc. of Corona, CA for the construction of sidewalk improvements, Grand Ave., Morrison Place to 650 feet southeast of Stoneman Street and Drainage Improvements in the Lake Elsinore Area of Riverside County. The authorized amount of the contract was \$313,204. The total amended contract amount (including quantity adjustments) is \$309,997.66, which is 1.0% less than the originally authorized amount.

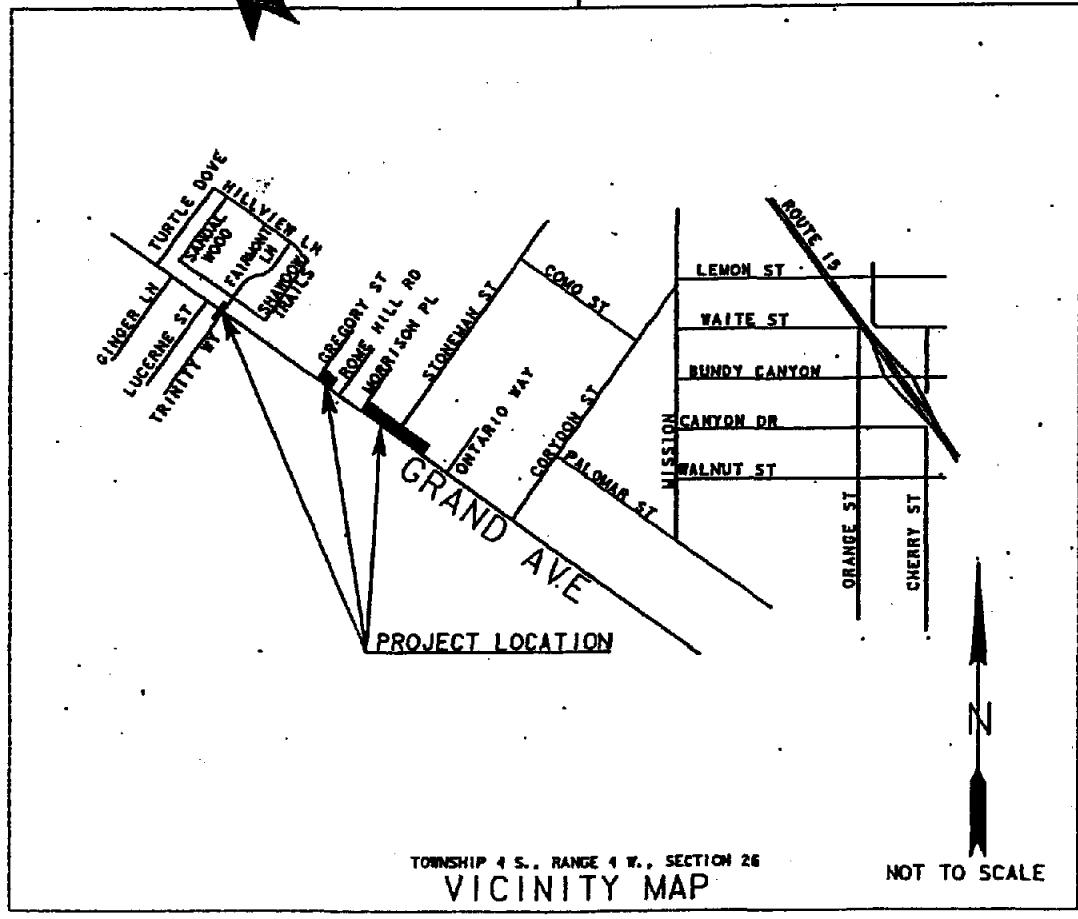
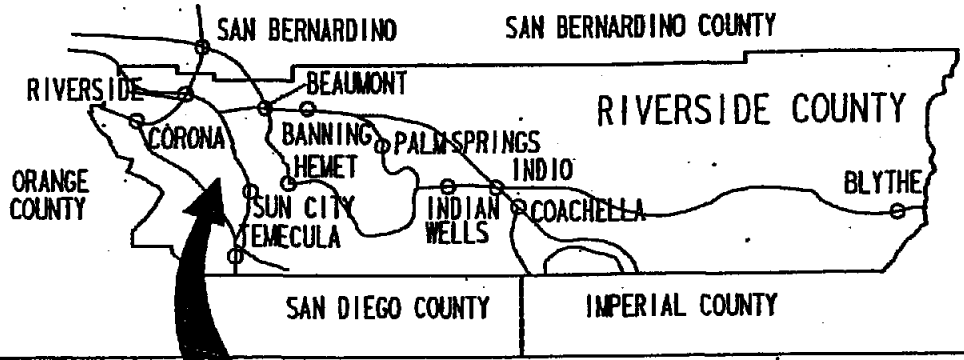
