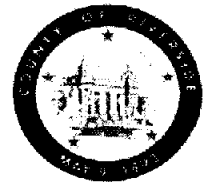

BACKGROUND: State statute requires the legislative body of a community facilities district to annually adopt, by resolution, the levy of special taxes to be enrolled for each fiscal year. Attached are the Resolutions for the Community Facilities Districts for which the Board serves as the Legislative Body. The status and key indicators for each District is shown on the attached Exhibit "A". The resolutions conform to the requirements of State statute as well as the Rate and Method of Apportionment for the respective Community Facilities Districts.

EXHIBIT A
Key Indicators Affecting FY 2008-2009 Community Facilities District Levies

The Community Facilities Districts (CFD's) with commercial development have continued to show some progress while the residential development has slowed in many of the Districts that have not already achieved full build out. For a second year in a row the slow down in the housing market within Riverside County and the economic challenges faced by many throughout the past year has had a noticeable impact on the CFD's delinquency rates which have increased in almost all of the Districts from the prior Fiscal Year. The Executive Office is diligently pursuing the delinquent parcels in accordance with the foreclosure covenant for each district. At this time, there are no Districts currently in jeopardy of default due to the delinquency but many have drawn on available surplus funds in order to ensure full debt service coverage.

There are five Districts that utilized a significant amount of their available surplus funds due to the higher delinquency rate in order to pay the current debt service. These Districts have an additional amount added to their annual levy for Fiscal Year 2008/09 in the event that the current delinquency trend continues and surplus funds will be needed to pay the full debt service without impacting their Reserve Fund. There is one District, CFD 85-2R, scheduled to reach full bond maturity this Fiscal Year. Details on the status of the various districts follow:

CFD 85-2 was refunded in May 2005. Fiscal Year 2008/09 is the final levy year for this District. Due to a considerably smaller debt service, the proposed levy is approximately 50% less than the prior Fiscal Year which includes a full year's administrative cost. A close-out analysis has been performed on the District to ensure that any available surplus funds are applied toward this final levy year. The tax delinquency rate for the prior Fiscal Year decreased slightly from 6.06% to 5.87% and was taken into consideration in the close out analysis.

CFD 86-1 was refunded in 2000. The refunding is supported by two levies, the total of which is the current levy supported by the property in the Original Area of the CFD and the property included in the Improvement Area. The levy in the Original Area will be paid in full in Fiscal Year 2011. The levy on the Improvement Area property may continue to fiscal year 2024. Although the tax delinquency rate for the prior Fiscal Year decreased slightly from 9.06% to 8.49% the high delinquency rate over the past two years has utilized some of the available surplus funds for the District. As a result, an additional \$270,000 has been added to the total levy for Fiscal Year 2008/09 to ensure sufficient debt service coverage in the event that a similar delinquency rate in the next Fiscal Year will not create a need to draw against the Reserve Fund.

CFD 87-1 was successfully refunded in July 2006. All parcels that were delinquent at the time of the refunding have cured any outstanding special tax amount or completed a payment plan with the County. The tax delinquency rate for the prior Fiscal Year has increased significantly from 3.95% the first year after the refunding to 9.98%. As a result of the refunding, there are surplus funds available that will be utilized to ensure a full debt service payment without drawing on the Reserve Fund.

Since CFD 87-5 restructured in April 1997, parcel development has nearly reached completion. In consideration of a high delinquency rate a surplus fund credit was not applied to offset the annual levy amount for this Fiscal Year. The tax delinquency rate compared to the prior Fiscal Year decreased from 9.59% to 7.29%.

The bonds were issued at a variable rate and are guaranteed by a letter of credit. Comerica Bank on behalf of the district issued a substitute letter of credit (LOC), which will expire on July 15, 2009. The LOC will automatically be extended for successive one (1) year periods until it is no longer required. Beginning in Fiscal Year 2005/06, per a Protocol Agreement, Pulte Homes opted to begin levying all parcels within the district at 100% of their maximum Special Tax rather than 90.9% of the maximum Special Tax amount. The excess proceeds are being used to perform optional bond calls thereby reducing the total amount of bonds outstanding. The tax delinquency rate for the prior Fiscal Year increased from 6.87% to 8.52%.

This district was successfully refunded and restructured in July 2006 significantly reducing the bonds outstanding for the district and subsequently reducing the total special tax amount to be collected by the district each Fiscal Year. Through the refunding, a large portion of the original district was removed and those parcels have completely prepaid any remaining special tax obligation related to the district as well as satisfied any outstanding delinquent amounts. The 57 remaining taxable parcels had also satisfied any outstanding delinquent amounts at the time of refunding. The tax delinquency rate for the first Fiscal Year after the refunding was 5.67% but, through payments, has decreased to 0.00%. The delinquency rate for Fiscal Year 2007/08 is currently 10.71%.

The district was successfully refunded in September 2006 and the Improvement Area was collapsed. The letter of credit held by Shea Homes is no longer required as they are responsible for less than 20% of the annual special tax for the District. The developed properties are able to generate sufficient revenues to meet the annual debt service obligation at a rate less than their maximum special tax. The Golf course is also fully operational and is open to the public. The tax delinquency rate for Fiscal Year 2007/08 decreased from 4.41% to 2.45%.

The District issued a new series of Bonds in May 2005, in part, to cover the refunding of the prior series of Bonds. This new series extended the final maturity of the district from 2016 to 2030. There was no new development within the district during the past Fiscal Year and there are still 4 parcels remaining undeveloped. As with last year, it will not be necessary to levy the undeveloped properties within the district since the revenue from only the developed properties is sufficient to meet debt service. There are two parcels that are delinquent for Fiscal Year 2007/08 which brings the delinquency rate to 16.95% representing \$54,749. The District historically has maintained a 0.00% delinquency rate but in light of the sharp increase in the rate, there has been an additional delinquency allowance of \$26,899.84 included in the annual levy for Fiscal Year 2008/09 to offset any future delinquency. This allowance represents a 10% increase to each of the developed non-residential parcels within the District.

The Bonds for CFD 03-1 were issued in August 2004. Although the construction of Newport Road has been completed, development has slowed considerably within this District over the past year and a significant increase was seen in the delinquency rate from the prior year. When comparing prior Fiscal Years, the majority of the rise in the delinquency rate, from 2.66% to 5.01%, is due to developer owned parcels. Due to the significant increase in the delinquency rate, an additional amount of \$146,741.10 was included in the annual levy for Fiscal Year 2008/09 in order to ensure sufficient coverage for the required debt service without impacting the Reserve Fund.

This district was levied for the first time in 2005-2006 after bonds were issued in August 2005. Full subdivision has occurred at 512 parcels and permits continue to be issued with three-quarters of the parcels qualifying as developed for this upcoming Fiscal Year. The delinquency rate for the prior Fiscal Year has increased dramatically from 7.59% to 13.29% but an allowance for delinquencies had been included in the annual levy amount that provided sufficient coverage to ensure a full debt service payment without a draw from the Reserve Fund. A similar delinquency allowance of \$279,523.32 will be included in the annual levy for the current Fiscal Year in the event of a continuation of this delinquency situation.

This District was formed in early 2006. The purpose of the CFD is to finance TUMF fee obligations. Bonds were issued in December 2007 and contained capacity for Capitalized Interest for the first 24 months which is to be supplemented by special tax monies collected from developed properties during the 24 month period. For Fiscal Year 2007/08, there were 267 developed parcels that received a special tax levy and for the upcoming Fiscal Year there are 338 qualifying developed parcels that will receive a special tax levy. The delinquency rate in the initial Fiscal Year is 14.79%.

This District was formed in July 2007 and bonds have not yet been issued, however, the RMA allows for the Special Tax to be levied prior to the issuance of bonds on any properties that qualify as developed. The purpose of the CFD is to finance TUMF and RBBB fees that will be used for the widening of Clinton Keith Road between Antelope Road and State Route 79. For Fiscal Year 2007/08, there were only 29 developed parcels that received a special tax levy and for the upcoming Fiscal Year there are 106 qualifying developed parcels that will receive a special tax levy. The delinquency rate in the initial Fiscal Year is 0.00%.

4 **RESOLUTION OF COMMUNITY FACILITIES DISTRICT NO. 85-2 (CALIFORNIA OAKS) OF**
5 **THE COUNTY OF RIVERSIDE AUTHORIZING THE LEVY**
6 **AND ENROLLMENT OF A SPECIAL TAX**
7 **FOR FISCAL YEAR 2008-2009**

8 **WHEREAS**, the Board of Supervisors of the County of Riverside (respectively, the "Board" and
9 the "County") by the adoption of Resolution No. 85-414 on July 30, 1985, as amended by Resolution No.
10 86-364 adopted on August 12, 1986, established Community Facilities District No. 85-2 (California
11 Oaks) of the County of Riverside, California (the "CFD"), pursuant to the Mello-Roos Community
12 Facilities District Act of 1982, as amended, Chapter 2.5 (commencing with Section 53311) of Part 1 of
13 Division 2 of Title 5 of the California Government Code (the "Act"); and

14 **WHEREAS**, pursuant to the provisions of the Act, proceedings to establish the Rate and Method
15 of Apportionment of Special Tax (respectively, the "Rate and Method" and the "Special Tax") for the
16 CFD were concluded by the Board's adoption of Ordinance No. 624 on December 3, 1985 (the
17 "Ordinance"); and

18 **WHEREAS**, the Board, acting *ex-officio* as the Legislative Body of the CFD (the "Legislative
19 Body"), enacted three resolutions that authorized the sale and issuance of three series of Special Tax
20 Improvement Bonds in the aggregate principal amount of \$44,000,000 (the "Special Tax Bonds"); and

21 **WHEREAS**, the Legislative Body by the adoption of Resolution No. 95-315 on October 24, 1995
22 authorized the sale and issuance of \$34,500,000 of Special Tax Refunding Bonds (the "Series 1995
23 Refunding Bonds") to refund the Special Tax Bonds; and

24 **WHEREAS**, the Legislative Body by the adoption of Resolution No. CFD 2005-04 on May 10,
25 2005 authorized the sale and issuance of \$7,240,000 of Special Tax Refunding Bonds (the "Series 2005
26 Refunding Bonds") to refund the Series 1995 Bonds; and

27 **WHEREAS**, all conditions precedent to the levy of the Special Tax in accordance with the
28 Ordinance have been satisfied;

NOW, THEREFORE, BE IT RESOLVED, FOUND, DETERMINED AND ORDERED by the

1 Board of Supervisors of the County of Riverside, California, acting *ex-officio* as the Legislative Body for
2 Community Facilities District No. 85-2 (California Oaks) of the County of Riverside, in regular session
3 assembled on July 15, 2008, as follows:

4 **Section 1.** Each of the above recitals is true and correct.

5 **Section 2.** Pursuant to the provisions of Resolution No. CFD 2005-04 and the Ordinance, the
6 Special Tax is to be levied up to an aggregate amount of \$1,100,000 for Fiscal Year 2008-2009 that is to
7 be apportioned among the parcels which comprise the CFD consistent with the Rate and Method as set
8 forth on a magnetic tape to be provided by Albert A. Webb Associates to the Auditor-Controller of the
9 County of Riverside (the "Auditor-Controller").

10 **Section 3.** The amount of Special Tax to be levied for fiscal year 2008-2009 does not exceed
11 the amount authorized by the Ordinance and approved by the qualified electors of the CFD.

12 **Section 4.** The proceeds of the Special Tax levy shall be used to pay, in whole or in part, the
13 costs of the following:

- 14 A. Payment of principal and interest on the outstanding Series 2005 Refunding Bonds;
- 15 B. Replenishment of the required bond reserve fund, or other reserve funds, if necessary.
- 16 C. Payment of the administrative expenses of the CFD, as provided in the Act, Resolution No.
17 CFD 2005-04, the Ordinance, and the Fiscal Agent Agreement pursuant to which the Series
18 2005 Refunding Bonds were issued.

19 The proceeds of the Special Tax levy shall be used as set forth above, and shall not be used for any
20 other purpose.

21 **Section 5.** The Auditor-Controller is hereby directed to enter the levy of the Special Tax for
22 fiscal year 2008-2009 as apportioned pursuant to the Rate and Method on all taxable parcels within the
23 CFD in accordance with this Resolution in a space marked "CFD 85-2 (California Oaks)" on the
24 equalized secured tax roll for fiscal year 2008-2009.

25 **Section 6.** The Auditor-Controller shall, at the close of the tax collection period, promptly
26 render to the CFD a detailed report showing the amount of Special Tax, penalties, interest and fees
27 collected, and from which parcels each was collected. Any expenses to be paid to the Auditor-Controller
28 for carrying out the foregoing responsibilities shall be collected in accordance with a contract entered into

1 between the CFD and the Auditor-Controller, pursuant to Section 29304 of the California Government
2 Code.

4 **RESOLUTION OF COMMUNITY FACILITIES DISTRICT NO. 86-1 (MENIFEE VILLAGE) OF**
5 **THE COUNTY OF RIVERSIDE AND IMPROVEMENT AREA NO. 1 THEREOF**
6 **AUTHORIZING THE LEVY AND ENROLLMENT OF A SPECIAL TAX**
7 **FOR FISCAL YEAR 2008-2009**

8 **WHEREAS**, the Board of Supervisors of the County of Riverside (respectively, the "Board" and
9 the "County") by the adoption of Resolution No. 86-267 on June 17, 1986, established Community
10 Facilities District No. 86-1 (Meniffee Village) of the County of Riverside, California (the "CFD"),
11 pursuant to the Mello-Roos Community Facilities District Act of 1982, as amended, Chapter 2.5
12 (commencing with Section 53311) of Part 1 of Division 2 of Title 5 of the California Government Code
13 (the "Act"); and

14 **WHEREAS**, pursuant to the provisions of the Act, proceedings to establish the Rate and Method
15 of Apportionment of Special Tax (respectively, the "Rate and Method" and the "Special Tax") for the
16 CFD were concluded by the Board's adoption of Ordinance No. 631 on July 8, 1986 (the "Ordinance No.
17 631"); and

18 **WHEREAS**, the Board, acting *ex-officio* as the Legislative Body of the CFD (the "Legislative
19 Body"), adopted Resolution No. 86-385 on August 26, 1986 to provide for the sale and issuance of
20 \$33,000,000 in Special Tax Improvement Bonds (the "Series 1986 Bonds"); and

21 **WHEREAS**, the Legislative Body, pursuant to the provisions of the Act, established Improvement
22 Area No. 1 of the CFD ("Improvement Area No. 1, and collectively with the CFD, the "CFD") on June
23 25, 1991 by the adoption of Resolution No. 91-330, and proceedings to amend the Rate and Method of
24 Apportionment of Special Tax for Improvement Area No. 1 were concluded by the Board's adoption of
25 Ordinance No. 713.1 on August 26, 1997, that amended Ordinance No. 713, adopted August 13, 1991
26 (collectively, with Ordinance No. 631, the "Ordinance"); and

27 **WHEREAS**, the Legislative Body by the adoption of Resolution No. CFD 2000-40 on January
28 25, 2000 authorized the sale and issuance of \$35,000,000 of Special Tax Revenue Bonds (the "Series
2000 Bonds") that, in part, refunded the Series 1986 Bonds; and

1 **WHEREAS**, all conditions precedent to the levy of the Special Tax in accordance with the
2 Ordinance have been satisfied;

3 **NOW, THEREFORE, BE IT RESOLVED, FOUND, DETERMINED AND ORDERED** by
4 the Board of Supervisors of the County of Riverside, California, acting *ex-officio* as the Legislative Body
5 for Community Facilities District No. 86-1 (Menifee Village) of the County of Riverside and
6 Improvement Area No. 1 thereof, in regular session assembled on July 15, 2008, as follows:

7 **Section 1.** Each of the above recitals is true and correct.

8 **Section 2.** Pursuant to the provisions of Resolution No. CFD 2000-40 and the Ordinance, the

14 3. Payment of the administrative expenses of the CFD, as provided in the Act, Resolution
15 Nos. 2008-286 and CFD 2008-04, the Ordinance, and the Fiscal Agent Agreement to
16 be prepared for each series of bonds.

17 The proceeds of the Special Tax levy shall be used as set forth above, and shall not be used for any
18 other purpose.

19 **Section 5.** The Auditor-Controller is hereby directed to enter the levy of the Special Tax for
20 fiscal year 2008-2009 as apportioned pursuant to the Rate and Method on all taxable parcels within the
21 CFD in accordance with this Resolution in a space marked "CFD 07-2 (Clinton Keith)" on the equalized
22 secured tax roll for fiscal year 2008-2009.

23 **Section 6.** The Auditor-Controller shall, at the close of the tax collection period, promptly
24 render to the CFD a detailed report showing the amount of Special Tax, penalties, interest and fees
25 collected, and from which parcels each was collected. Any expenses to be paid to the Auditor-Controller
26 for carrying out the foregoing responsibilities shall be collected in accordance with a contract entered into
27 between the CFD and the Auditor-Controller, pursuant to Section 29304 of the California Government
28 Code.
