

SUBJECT: AUGMENTATION TO FUNERAL BURIAL / DOMESTIC VIOLENCE PROGRAM GRANT REVOLVING FUND

RECOMMENDED MOTION: Move that the Board of Supervisors:

1. Approve the \$75,000 augmentation to the Funeral Burial/Domestic Violence Program Grant award received from the Victim Compensation and Government Claims Board to the increased amount of \$160,000.
2. Approve Resolution No. **2008-272** submitted herein
3. Authorize the District Attorney to sign the standard agreement amendment number 1 for agreement number VCGC7051 on behalf of the Board.

BACKGROUND: The purpose of the grant is to establish a process by which the County may pay verified funeral/burial expenses pending approval by the California Victim Compensation and Government Claims Board when a provider of funeral/burial services requires immediate payment and is unwilling to wait for reimbursement through the normal claims process. This program also pays verified emergency expenses for domestic violence relocation awards. The grant award is maintained in the District Attorney's Victim Witness Claims revolving fund, which is used solely for payment of emergency grant expenses. No County matching funds are required.



8 WHEREAS, the County of Riverside desires to undertake a certain project designated the Funeral
9 Burial/Domestic Violence Program to be funded in part from funds made available through the Victim
10 Compensation and Government Claims Board (hereinafter referred to as VCGCB).

11 NOW, THEREFORE BE IT RESOLVED AND ORDERED by the Board of Supervisors of the
12 County of Riverside, State of California, in regular session assembled on _____,
13 2008, that the District Attorney of the County of Riverside, State of California is authorized, on its behalf
14 to submit the attached proposal to the VCGCB and is authorized to sign and approve on behalf of the
15 Board of Supervisors of the County of Riverside the attached contract for an increase of \$75,000 dollars
16 to a total of \$160,000 dollars, including any extensions or amendments thereof.

17 BE IT FURTHER RESOLVED that the resolution shall be in effect for a three-year period
18 beginning July 1, 2006 and ending June 30, 2009.

19 BE IT FURTHER RESOLVED that grant funds received hereunder shall not be used to supplant
20 expenditures controlled by this body.
