**BACKGROUND:** On July 31, 2007, Agenda Item 3.69, the Board ratified and executed the Professional Services Agreement with the Volunteer Center of Riverside County for a crisis and suicide intervention hotline. The Department of Mental Health is requesting to continue contracting with the Volunteer Center for FY 08/09 in the amount of \$50,000.

**SUBJECT:** Ratify contract renewal with Volunteer Center of Riverside County.

**BACKGROUND (Continued):**

**PERIOD OF PERFORMANCE:** The contract renewal with the Volunteer Center of Riverside County will be effective July 1, 2008 through June 30, 2009. The Department is requesting the Purchasing Agent be given the authority to sign amendments and exercise the renewal options with the Volunteer Center of Riverside County for an amount not greater than \$50,000 annually through June 30, 2013.

**FINANCIAL IMPACT:** The renewal agreement with the Volunteer Center of Riverside County will remain at \$50,000. There are sufficient funds in the Department's budget to provide for the contract. These funds are budgeted annually. No additional County funds are required.

**JUSTIFICATION FOR DELAY:** Contracts were not returned in time from the contractor.
