SUBJECT: Idyllwild Nature Center Entry Road and Parking Lot Improvement Project Agreement – District III

RECOMMENDED MOTION: That the Board:

- 1) Authorizes the Chairman to execute the agreement between the Riverside County Regional Park and Open-Space District (Park District) and Wheeler Paving Inc., in the amount of \$60,210.15 for road and parking lot improvements at Idyllwild Nature Center, Idyllwild, California; and
- 2) Instructs the Clerk of the Board to return four (4) executed copies of the agreement to the Park District for transmittal and file.

BACKGROUND: On June 24, 2008, per Board Minute Order 13.1, the Clerk of the Board advertised for bids for the Idyllwild Nature Center Entry Road and Parking Lot Improvement Project. Bids were received and publicly opened by the Clerk on July 9, 2008, with the Clerk receiving 12 bids. District staff reviewed the bids and found the low bid was submitted by Wheeler Paving Inc., General Engineering Contractor, Riverside, California in the amount of \$60,210.15.

The Development improvements to the Nature Center shall consist of paving improvements to the existing entrance road and a parking lot. The work shall include pulverizing existing pavement, scarifying, compacting, paving asphalt, striping, and signage to meet ADA requirements. All improvements have been designed to conform to federal and State access guidelines per the Americans with Disabilities Act. The office of County Counsel has approved the summary, proposal and agreement as to legal form.
