SUBJECT: Approval of the Department of Mental Health Managed Care, Medi-Cal Hospital Renewals for FY 08/09.

RECOMMENDED MOTION: Move that the Board of Supervisors:

- 1) Approve the Department of Mental Health Managed Care, Medi-Cal Hospital Renewals with providers as specified in Attachment A for FY 08/09;
- 2) Authorize the Chairman of the Board to sign the contract renewals; and
- 3) Authorize the Riverside County Purchasing Agent to add and annually renew or sign ministerial amendments through June 30, 2013.

BACKGROUND: The Department of Mental Health (DOMH), functioning as the Mental Health Plan (MHP), is responsible for authorization and payment of the State Medi-Cal match for all medically necessary acute psychiatric inpatient hospital services for Riverside County Medi-Cal beneficiaries. The services provided by Managed Care, Medi-Cal hospitals include Psychiatric inpatient hospital services for emotionally disturbed minors and seriously mentally ill older adults in need of acute psychiatric inpatient hospital services.

SUBJECT: Approval of the Department of Mental Health Managed Care, Medi-Cal Hospital Renewals for FY 08/09.

BACKGROUND: (continued):

Specific services include psychiatric evaluation and treatment services, routine medical, education, room and board, and all necessary reports. Transportation services for clients back to their living situation may also be provided at the time of discharge.

The County of Riverside, DOMH is mandated to contract with Traditional Hospitals, as defined by Title 9, CCR, Section 1810.430 (a). The specified Managed Care, Medi-Cal Hospital contracts only cover services that are provided to Medi-Cal clients, in which the services these clients receive are 100% Medi-Cal reimbursable by the State. The rate of payment for these contract services is negotiated by the County of Riverside for each facility location. Payments are made to the hospital by the State, and the State then offsets payments made on behalf of the County of Riverside DOMH by a corresponding reduction in the DOMH's portion of State Realignment funds. Therefore, the DOMH is requesting that the Chairman of the Board of Supervisors sign the FY 08/09 renewals, and authorize the Riverside County Purchasing Agent to renew these contracts annually thereafter through June 30, 2013.

PERIOD OF PERFORMANCE:

The specified hospital contract renewals have a period of performance from July 1, 2008 through June 30, 2009, and may be renewed annually through June 30, 2013 upon mutual agreement by both parties. These Managed Care contracts contain termination provisions in case of the unavailability of any federal, state, and/or county funds.

FINANCIAL IMPACT:

These contract agreements reflect a maximum contract amount of zero dollars (\$0) for the hospitals providing the described services to Riverside County Medi-Cal clients. The DOMH serves as the monitoring agency for the services provided by the specified Managed Care, Medi-Cal Hospitals. However, these contracts are 100% Medi-Cal reimbursable directly to the Hospitals from the State.

Attachment A outlines the maximum contract amounts. There are sufficient funds in the Department's proposed budget for FY 08/09 to provide for all contracts listed on Attachment A and no additional County funds are required.

JUSTIFICATION FOR DELAY:

The DOMH received the Managed Care, Medi-Cal Hospital renewal agreements back from all contractors the week of July 7, 2008.

Managed Care hospital contracts provide psychiatric inpatient services for the care and treatment of an acute episode of mental illness for Riverside County Medi-Cal beneficiaries. Services include clinical and medical services, which are generally recognized and accepted for the diagnosis and treatment of mental illness or serious emotional disturbance, as clinically necessary.
