SUBJECT: Acceptance of a 2008 Grant Award from the U.S. Department of Justice, Drug Enforcement Administration for a Domestic Cannabis Eradication/Suppression Program

RECOMMENDED MOTION: Move that the Board of Supervisors:

1. Accept an award of \$65,000 from the 2008 Domestic Cannabis Eradication/Suppression Grant Program of the U.S. Department of Justice Drug Enforcement Administration (DEA);
2. Authorize the Chairman to sign the Letter of Agreement No. 2008-36;
3. Authorize the Chairman to sign grant assurances, and certifications regarding lobbying and debarment, suspension, and other responsibility matters; and
4. Authorize the Sheriff or his designee to sign any future modifications, requests for advances or reimbursements and reports on behalf of the County.

BACKGROUND: Over the last twenty years, the County has received funding from the Domestic Cannabis Eradication/Suppression Grant Program. To a large extent, the Sheriff's Department uses these funds to defray the cost of Deputy and Investigator overtime expended in its cannabis eradication effort. The Department also sends the DEA samples of the confiscated marijuana to the National Institute of Drug Abuse Potency Monitoring Program.
