3. Authorize and direct the Director of the Department of Facilities Management to certify acceptance of any documents running in favor of the County, as part of this transaction; and
4. Authorize the Director of the Department of Facilities Management, or his designee, to execute any other documents and administer all actions necessary to complete this transaction.

**BACKGROUND:**

With approval of the California Environmental Quality Act (CEQA) Final Environmental Impact Report (FEIR), it is now possible to proceed for site acquisition and development for the Public Safety Enterprise Communications Project Site (PSEC). The FEIR addresses mitigation requirements and unavoidable environmental impacts stemming from the construction and operation of the proposed public safety project. This Board submittal is for a PSEC site located in Quail Valley. The Phase I report for said subject property indicates no contamination.

The Quail Valley site (Exhibit I) is a new microwave and radio location offering coverage in a poorly served area near Canyon Lake. A county owned site offers reduced life cycle costs, strong site security and good communications reliability. The acquisition process involves the purchase of two vacant lots of approximately 0.5 acres total. The purchases are from willing sellers at \$45,000 for each lot plus \$7,500 each for transaction costs, for a total of \$105,000. The site is located on an existing unpaved road with electrical service nearby and is sited near a water tank to reduce vegetative disturbance and visual impacts on the rural area.

This resolution has been reviewed and approved by County Counsel as to legal form.

documents to complete this purchase of real property.

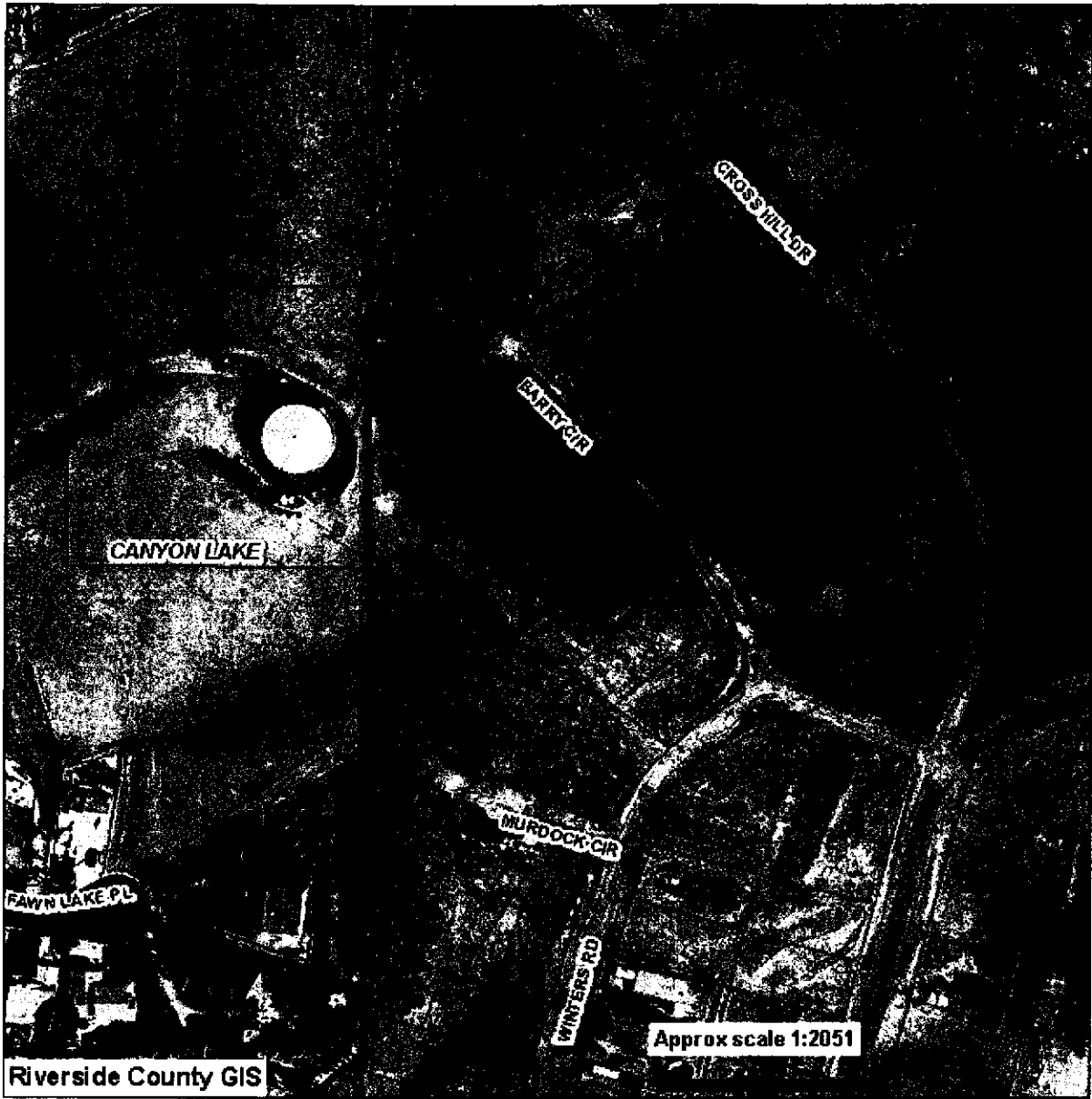
