SUBJECT: Construction of Landfill Gas Collection System Expansions for Fiscal Year 2008/2009 at the Badlands and Lamb Canyon Landfills

RECOMMENDED MOTION: That the Board:

1. Accept the bid submitted by BAS Construction, LP in the amount of \$177,844.92 for the Construction of Landfill Gas Collection System Expansions for Fiscal Year 2008/2009 at the Badlands and Lamb Canyon Landfills; and
2. Authorize the Chairman to execute the Agreement on behalf of the Department.

BACKGROUND: The Board authorized the Department to advertise for bids on June 24, 2008. On July 31, 2008 the Department opened bids for the Landfill Gas Collection System Expansions for Fiscal Year 2008/2009 at the Badlands and Lamb Canyon Landfills. The Department received two bids in the amount of \$177,844.92 and \$282,810.00. The engineer's estimate for this project is \$266,510. BAS Construction, LP submitted the lowest bid of \$177,844.92. The Department has determined that BAS Construction, LP has the necessary minimum experience and capability to perform this work in accordance with the contract documents. County Counsel has determined that the bid documents are in order.
