RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the First 5 Agreement 1022 OP-08 between Riverside County Children and Families Commission and Riverside County Community Health Agency, Department of Public Health, Loving Support Breastfeeding program for the period of July 1, 2008 through June 30, 2009, in the amount of \$ 924,671 with options to extend the term for one (1) additional term of three (3) years; and
- 2) Authorize the Purchasing Agent to sign subsequent amendments not to exceed authorized amount, including extension amendments until June 30, 2012.
- 3) Authorize the Chairperson to sign four (4) originals of said Agreement on behalf of the County.

SUBJECT: Ratify the First 5 Riverside Agreement 1022 OP-08 between Riverside County Children and Families Commission and the Community Health Agency, Department of Public Health, Nutrition Services Branch.

BACKGROUND: Riverside County Community Health Agency, Department of Public Health, Nutrition Services Branch is a continuing contractor with the Riverside County Children and Families Commission.

The Riverside County Children and Families Commission has awarded Riverside County Community Health Agency Department of Public Health funding in the amount of \$ 924,671 for the Loving Support Breastfeeding Program (LSBP).

The Loving Support Breastfeeding Program (LSBP) offers breastfeeding education, assistance and support to all new families and provides information and resources to medical providers and hospitals that are proven effective in increasing breastfeeding initiation and duration among women. The program includes operation of a 24-hour/7-day per-week Breastfeeding Helpline, individualized instruction for mothers and provider education and trainings.

FINANCIAL INFORMATION: The Riverside County Children and Families Commission awarded Riverside County Community Health Agency Department of Public Health continued funding in the amount of \$ 924,671. The program year is based on the FY July 1, 2008 – June 30, 2009.
